

2010 Hunting Atlas Updates – Deletions

Map Sheet 14 - Beadle County

Deletion 08/24/10: Walk-in-Area is located approximately 1 mile directly north of Wessington on 374th Avenue. The Walk-in-Area is 320 acres, the western half of the section with 374th Avenue bordering the western edge and 200th Street bordering the northern Edge.

Map Sheet 15 – Brookings County


Deletion 09/24/10: Walk-in-Area is located in northeastern Brookings County, approximately 2 miles east and 4 miles south of Astoria, SD. The Walk-in-Area is bordered by 485th Avenue/County Highway 29 to the east and 199th Street/County Highway 44 to the North. The Walk-in-Area has a farmhouse site in the middle which is excluded from the Walk-in-Area.

Map Sheet 10 – Day County

WIA Deletion 08/02/10: Walk-in-Area with special rules (rule #8) located approx 1 mile south and 2 miles east of Webster, SD on the north side of 143rd Street. 120 acres on the southern half of the southeast quarter and the southeast quarter of the southwest quarter is no longer Walk-in-Area.

Map Sheet 17 – Haakon County

WIA Deletion 07/20/10: Walk-in-Area located approximately 3.5 miles northwest of Midland, SD. The eastern half of the full 1 square mile section located directly north of 228th Street and directly east of Dusty Ridge Road / 246th Ave. is no longer in Walk-in-Area Program. A map showing the partial Walk-in-Area deletion is provided below. The portion of Walk-in-Area deleted is depicted in gray.



Map Sheet 17 - Haakon County

WIA Correction 08/24/10: Walk-in-Area is located 5 miles east of the Haakon/Pennington County line along 218th Street. Walk-in-Area is located south of 218th Street. 160 acres located in the Northeastern quarter of the section should be located in the Northwestern quarter of the same section.

Map Sheet 22 – Jackson County


WIA Correction 07/26/10: Walk-in-Area is located in northeastern Jackson county approximately 3.5 miles north of I-90 on the border of the Jackson/Jones County line. The 160 acres located 2 miles east of Stanford Road and 1 mile south of Church Road is not Walk-in-Area. The 160 acres of actual Walk-in-Area should be located in the southeast quarter of the same section or the 160 acres directly south of the Walk-in-Area shown on the 2010 Hunting Atlas paper version.

Map Sheet 25 – Minnehaha County

WIA Deletion 08/24/10: Walk-in-Area is located in eastern Minnehaha County. The Walk-in-Area located approximately 5 miles directly North of Humbolt, SD is no longer Walk-in-Area. This Walk-in-Area shares a border with a Game Production Area.

Map Sheet 2 – Perkins County

WIA Deletion 9/24/10: Walk-in-Area is located approximately 1 mile west of the northernmost tip of Shadehill Reservoir in eastern Perkins County. The Walk-in-Area encompasses about 700 acres and contains a portion of Burdick Road. A map showing the WIA deletion is provided below. The portion of Walk-in-Area removed is depicted in gray.



Map Sheet 9 – Spink County

CREP Deletion 9/10/10: CREP acres are located approximately 4 miles South and 2 miles west of Conde, SD. The CREP acres consist of 2 thin 15 acres parcels located on the eastern edge of 404th Avenue and between 157th Street and 158th Street. Another 15 acre parcel of CREP is located on the intersection of 404th Avenue and 159th Street. A map showing the CREP acres is provided below. The parcels colored in gray are the former CREP acres which have been deleted.
