

# MULTIPLE PARK ENTRANCE PERMIT APPLICATION

State law and GFP rules provide that persons with three or more vehicles currently registered to them may purchase more than one half-price annual park entrance permit.

**1. Complete the following:** I have already purchased an annual (\$30) and a half-price annual (\$15) park entrance permit for the current calendar year, or I am enclosing (\$45) for two permits.

**All motorized vehicles (licensed or un-licensed) must possess a Park Entrance License to operate in a State Park Fee Area.**

**Cars, Trucks, ATVs, ORVs and Motorcycles:** Must be licensed and operated by a licensed driver.

**Golf Carts (gas or electric powered):** Need not be licensed but must have a headlight, brake light and rearview mirror and must be operated by a licensed driver.

**Moped/Scooters with motors less than 50cc (gas or electric powered):** Need not be licensed but must have a headlight, brake light, mirror and horn and must be operated by a licensed driver.

**2. Submit the following to the Pierre Office or any State Park or Recreation Area.**

Photocopies of proof of ownership\* for the two vehicles already permitted for the current park license year and for all other vehicles for which you want to permit with the half-price permits. **NOTE: All vehicles to be permitted must have proof of ownership under the same name(s) or live in the same household with the same address.**

For example, if you own three vehicles and wish to buy one additional half-price permit (\$15) you must send in proof of ownership for **all three vehicles**. Send in four forms if you own four vehicles to receive two additional half-price permits, and so forth.

- \_\_\_\_ To buy ONE additional permit--  
send 3 proofs of ownership\* and \$15
- \_\_\_\_ To buy TWO additional permits--  
send 4 proofs of ownership\* and \$30
- \_\_\_\_ To buy THREE additional permits--  
send 5 proofs of ownership\* and \$45
- \_\_\_\_ To buy FOUR additional permits--  
send 6 proofs of ownership\* and \$60
- \_\_\_\_ To buy FIVE additional permits--  
send 7 proofs of ownership\* and \$75
