Antlerless only season: Only those tags specifically designated as "antlerless" are valid from December 12-20. Any Deer, Any Buck, or Any Whitetail tags do not convert for this antlerless only season.

IMPORTANT SEASON INFORMATION

Eligibility: Residents and nonresidents are eligible for all units, with some exceptions.

REMINDER: This season is a part of the combined deer draw in which individuals are restricted to the number of applications contingent on other applications and licenses held. Find detailed information at <https://gfp.sd.gov/hunt-fish-license/>.

Group Number Maximum: Six (6) applicants

Tribal lands: State licenses are valid on private, deeded lands within the exterior boundaries of an Indian reservation. Persons applying to hunt on Tribal lands should contact the appropriate tribal office concerning tribal lands.
