- CWD Stakeholder Group meeting was held on 11/28/18
- Of the 26 stakeholders, 20 members were present
- High level of engagement and input from the group
- Presentations were provided by SD Game, Fish and Parks; SD Animal Industry Board; and Wind Cave National Park
- Much discussion on the following topics:
 - Background of disease, history, and concerns in South Dakota
 - Inter and intra-state carcass transportation and disposal
 - Communication and outreach to hunters and the public
 - Captive cervids
 - Game processing
 - Potential to work with commercial processors, taxidermists, and SD Dept. of Transportation on obtaining samples from desired areas
 - Baiting and feeding of wildlife
 - Scents and lures
 - Future surveillance needs and logistics

Update Since November Commission Meeting



- Held first stakeholder group meeting
- GFP's Podcast and Blast includes a conversation on chronic wasting disease
- Met with SD Department of Transportation on using vehiclekilled deer and elk for disease testing
- Discussion with SD Taxidermy Association on partnering with taxidermists to assist with collection of samples
- Upcoming meeting with SD Animal Industry Board to discuss a Memorandum of Understanding related to CWD management
- Contacted several conservation organizations indicating willingness to meet and discuss draft plan
- Will be attending GFP regional meetings to discuss draft plan

Update Since November Commission Meeting



- Internal work group meeting on 12/14/18 to discuss draft objectives and strategies of action plan
- Several staff assisting with various segments of the draft plan
- Communications staff continue to discuss methods and timing of communication/outreach with our hunters and public
- Initial discussions have occurred on public open houses
- Discussions have occurred with SDSU lab and their capabilities to assist with enhanced surveillance and testing efforts
- Discussions will soon occur with some commercial processors to determine feasibility of storing heads for collection of samples
- Interviews with media on CWD management

Timeline Moving Forward

- January 10-11: provide next update to GFP Commission
- February 1: make draft action plan available for public comment
- February 22: end of public comment period on 1st draft
- **February March**: present information at GFP regional meetings, meet with organizations and other stakeholders on draft action plan, and solicit public comment
- **February 28-March 1**: present summary of modifications incorporated from public comment and provide 2nd draft to Commission for review and additional public comment
- March 11: next CWD stakeholder group meeting
- March 12-19: hold four public open houses across the state
- March 20-21: staff meet to discuss and develop Dept. recommendations
- **April 4-5**: ask GFP Commission for adoption of final draft <u>and</u> present Department recommendations related to applicable administrative rules
- May 2-3: ask GFP Commission to finalize proposed rule changes and follow-up with implementation of action plan
