License: Commercial Captive Game Bird License, which authorizes the licensee to possess, produce, release from captivity, sell, offer for sale, and ship game birds as provided in this chapter.

Fees: Resident License - \$50
Nonresident License - \$100

Submission: Payment in the form of personal check, money order, cashier's check or cash must be submitted with application. Cash is not recommended. Bad checks will void license. Completed application (both front and back) and fee must be submitted to:
