CALL MEETING TO ORDER AT 1:00 PM CT/12:00 PM MT - DAY 1, 11:56 MARK

Chairman Russell Olson called the meeting to order at 1:00 pm CT at Good Earth State Park Visitors Center in Sioux Falls, South Dakota. Commissioners Travis Bies, Stephanie Rissler, Russell Olson, Jon Locken, Julie Bartling, Robert Whitmyre, and Chuck Spring were present. The public and staff could listen via SDPB Livestream, participate via video conference, or in person, with approximately 96 total participants via zoom or in person.

DIVISION OF ADMINISTRATION

1. CONFLICT OF INTEREST DISCLOSURE - DAY 1, 00:12:15 MARK

Chairman Olson called for a conflict of interest to be disclosed. None were present.

2. APPROVE MINUTES OF THE JULY 2022 MEETING – DAY 1, 00:13:38 MARK

Chairman Olson called for any additions or corrections to the regular meeting minutes of July 7-8, 2022. Minutes are available at https://gfp.sd.gov/commission/archives/. Motion by Rissler with second by Bartling to APPROVE THE MINUTES OF THE JULY 7-8, 2022, REGULAR MEETING. Motion carried unanimously.

3. ADDITIONAL COMMISSIONER SALARY DAYS – DAY 1, 00:13:59 MARK

Chairman Olson called for additional salary days. No additional commission salary days were submitted for approval.

4. SOUTH DAKOTA PARKS & WILDLIFE FOUNDATION UPDATE - DAY 1, 00:14:30 MARK

Kristina Coby, Executive Development Director of the South Dakota Parks & Wildlife Foundation, provided an update on Foundation activities. Her update included a thank you to all commissioners for attending the Outdoor Campus - Sioux Falls Anniversary & Campaign Kick-Off the night before their meeting. Kristina shared that the Foundation has committed to raising \$3 million of the approximate \$7 million price tag of the Outdoor Campus expansion project. The project includes the addition of indoor and outdoor bb gun/archery ranges, new classrooms, remodeled bathrooms, and additional storage and office space to accommodate programming needs. The estimated timeline includes outdoor range construction beginning in 2024.

5. SECOND CENTURY HABITAT FUND UPDATE - DAY 1, 00:18:42 MARK

Brian Bashore, Executive Director of the Second Century Habitat Fund, informed the Commission that the SCHF has raised \$182,000 this year, with over \$1.15 million in the pipeline from federal grants and private corporate donors. SCHF has enrolled 594 acres into the Workinglands Program in 2022 at an investment of \$195,000, bringing the total to 7,512 acres at \$1,240,246 invested in landowner contracts and seed. SCHF will also launch their 2022/23 raffle of a Toyota Tundra pickup truck with 165 Alumacraft Boat around the 1st of October.

6. GO OUTDOORS SOUTH DAKOTA UPDATE -FISK - DAY 1, 00:22:07 MARK / BECHARD - DAY 1, 1:45:24 MARK

Keith Fisk, Licensing Program Administrator, updated the commission virtually on the Combined Deer drawing and tag/license printing status. Customers should receive their tag/license by mid-September. All other limited draw printing is moving forward as expected and should be mailed daily. GFP is prepping to open the Landowner-Own-Land licenses in mid-September and preparing for a busy Fall with pheasant season not far away. Keith also answered several questions regarding the deer draws and eligibility at different draw levels.

Jodi Bechard, Parks Business Manager, virtually reported on the parks side of Go Outdoors South Dakota. She indicated that the initial launch of Go Outdoors had a few bumps but is moving smoothly now. GF&P pushed

through some updates and items from internal and external customers to get fixed or changed over the winter months.

7. NON-MEANDERED WATERS UPDATE - DAY 1, 00:30:58 MARK

Rhet Russell, Wildlife Biologist, reported there are currently 43 posted closures for a total of 5,758.25 acres ranging from 0.25 to 1,010 acres in 11 counties, most of which are in the northeast region. These acreages have remained consistent, though they vary by a couple of thousand acres each year depending on water levels and weather. Currently, 12 agreements with landowners provide access to 13,000 acres of non-meandered waters. These agreements range in length from a few months up to ten years. The department will continue to work with landowners on possible contracts to keep the non-meandered waters for recreational use.

8. SHERIDAN LAKE WALLEYE LIMIT

Edel - Day 1, 58:54 mark / Kirschenmann - Day 1, 1:04:35 mark; Day 1 – 1:31:01 mark Denial Resolution - Day 2, 00:32:06 mark

Petition received August 7, 2022, from Ken Edel of Rapid City, SD, requesting a change to the state walleye daily limit to four fish, no minimum, one fish over twenty inches.

Department recommendation: Denial, as the department does not want to create inconsistency in the statewide walleye regulations and believes the current and future stocking rates should sustain overall walleye limits.

Motion by Rissler, seconded by Spring to DENY THE PETITION ON A STATEWIDE WALLEYE LIMIT. Motion carried unanimously.

Motioned by Rissler, seconded by Bies to ADOPT RESOLUTION 22-16 TO DENY THE PETITION ON A STATEWIDE WALLEYE LIMIT. Motion carried unanimously.

PROPOSALS

9. SPRING TURKEY - DAY 1, 00:46:35 MARK

9A. CUSTER STATE PARK SPRING WILD TURKEY HUNTING SEASON - CHAPTER 41:06:15

Department recommended changes from last year:

- 1. Change the season start date from the 2nd to the 3rd Saturday in April.
- 2. Format and style change for the maximum number of licenses and preference point unit.

Department recommended changes to proposal:

- 1. Changes the proposed season start date from the 2nd to the 4th Saturday in April.
 - a. April 22-May 21, 2023
 - b. April 27-May 19, 2024

Motioned by Rissler and seconded by Locken to APPROVE THE AMENDMENT TO THE PROPOSAL. Motion carried unanimously.

Motioned by Locken and seconded by Whitmyre to APPROVE PROPOSAL AS AMENDED. Motion carried unanimously.

9B. Spring Wild Turkey Hunting Season - Chapters 41:06:13 & 41:03:01

Department recommended changes from last year:

- 1. Modify the season dates for all spring turkey hunting seasons to begin on the third Saturday of April and end on May 31.
- 2. Adjust the maximum number of licenses available in administrative rule from no more than 5,807 to 10,000 one-tag "male turkey" licenses and from no more than 600 to 2,500 two-tag "male turkey" licenses.

- 3. Eliminate Unit BST-BH2, which provides for a second Black Hills spring turkey licenses for resident hunters.
- 4. Modify the season dates for those prairie units with split season seasons.
- 5. Modify the valid time during the season when access permits are valid for Good Earth State Park and Adams Homestead and Nature Preserve.
- 6. Modify the valid time during the season when hunters can have uncased weapons within the boundary of Sica Hollow State Park.

Department recommended changes from the proposal:

- 1. Change the proposed season start date from the 3rd Saturday in April to the 2nd Saturday in April for the prairie spring turkey season. This would be a no change to the current administrative rule.
 - a. April 8 May 31, 2023
 - b. April 13 May 31, 2024
- 2. Change the proposed season start date from the 3rd Saturday in April to the 4th Saturday in April for the Black Hills spring turkey season.
 - a. April 22 May 31, 2023
 - b. April 27 May 31, 2024
- 3. Withdraw the proposed changes for the season dates for those prairie units with split seasons. This would be a no change to the current administrative rule.
- 4. Withdraw the proposed changes to modify the valid time during the season when access permits are valid for Good Earth State Park and Adams Homestead and Nature Preserve. This would be a no change to the current administrative rule.
- 5. Withdraw the proposed changes to modify the valid time during the season when hunters can have uncased weapons within the boundary of Sica Hollow State Park. This would be a no change to the current administrative rule.
- 6. For archery and mentored spring turkey licenses, season start dates would align with the prairie and Black Hills seasons.
- 7. For the Fall River prairie hunting unit, remove the allowance to hunt within one mile of the Cheyenne River in the Black Hills hunting unit.

Motioned by Rissler and seconded by Bartling to APPROVE THE AMENDMENTS TO THE PROPOSAL. Motion carried unanimously.

Motioned by Whitmyre and seconded by Bartling to APPROVE PROPOSAL AS AMENDED. Motion carried unanimously.

Jon Kotilnek, senior staff attorney, opened the floor for discussion from those in attendance on matters of importance to them that may not be on the agenda. The open forum started at 2:07 pm MT.

- Jerry LeClair of Sioux Falls, SD. Expressed concern about docks and fish cleaning stations.
- Mary Kay Fausch of Harrisburg, SD, representing the Timber Ridge HOA, expressed opposition to Spring Creek Golf Course being turned into a campground.

10. FISHING REGULATIONS - DAY 1, 1:47:20 MARK

10a & 11. Ice Shack Removal Dates & Fish Limits - Chapters 41:07:01 & 41:07:03

Proposed Changes:

1. Remove restrictions on when ice fishing shelters can be left overnight on public waters.

Department recommended amendments to the proposal:

- 1. Remove ice fishing shelter removal dates for inland waters and change the ice fishing shelter removal date on South Dakota Minnesota border waters from the last day in February to March 5.

 Motioned by Whitmyre, seconded by Locken to APPROVE AMENDMENT TO PROPOSAL. Motion carried unanimously.
 - Motioned by Whitmyre, seconded by Locken to ADOPT THE FINALIZATION AS AMENDED. Motion carried unanimously.
- 2. Remove language referencing gear specifications for the noncommercial take of smelt. *Motioned by Bartling, seconded by Rissler to ADOPT THE FINALIZATION. Motion carried unanimously.*
- 3. Remove the 15" minimum length limit for largemouth and smallmouth bass on Burke Lake in Gregory County and put in place a 15" minimum length limit for largemouth and smallmouth bass on Lake Mitchell in Davison County.
 - Motioned by Bartling, seconded by Spring to ADOPT THE FINALIZATION. Motion carried unanimously.

10c. Importation of Fish - Chapter 41:09:08

Proposed change:

1. Modify language in the rule listing importation requirements of fish to better describe current definitions of pathogens or diseases of regulatory concern (41:09:08:03.03).

Motioned by Bartling, seconded by Whitmyre to ADOPT THE FINALIZATION. Motion carried unanimously.

10d. Hoop Nets, Traps, Setlines, and Floatlines - Chapter 41:07:08

Department recommendations are as follows:

- 1. Change check times for hoop nets, traps, and setlines from 72 hours to 24 hours. *Motioned by Bies, seconded by Rissler to ADOPT THE FINALIZATION. Motion carried unanimously.*
- 2. Modify language to allow someone besides the licensee to run hoop nets, traps, setlines, and floatlines if the licensee is present.
 - Motioned by Locken, seconded by Bies to ADOPT THE FINALIZATION. Motion carried unanimously.

10E & 10F, PADDLEFISH SEASON & PERSONS WITH DISABILITIES - CHAPTERS 41:07:05 & 41:09:12

Department recommendations are as follows:

- 1. Remove language regarding ZZ1 units (preference point only) for archery and snagging paddlefish seasons, as these units are no longer available.
 - Motioned by Bartling, seconded by Rissler to ADOPT THE FINALIZATION. Motion carried unanimously.
- 2. Add crossbows as a legal method of take for paddlefish during archery seasons. *Motioned by Bies, seconded by Rissler to ADOPT THE FINALIZATION. Motion carried unanimously.*
- 3. Provide a permit to allow for assistance to be given to a disabled angler while participating in lawful fishing activities.
 - Motioned by Whitmyre, seconded by Bartling to ADOPT THE FINALIZATION. Motion carried unanimously.

11. THREATENED AND ENDANGERED SPECIES - PEREGRINE FALCON - DAY 1, 2:09:00 MARK

Proposed Changes:

1. Down list the Peregrine Falcon (Falco peregrinus) from endangered to threatened on the list of state threatened and endangered bird species.

Motioned by Bies, seconded by Bartling to ADOPT THE FINALIZATION. Motion carried unanimously.

DIVISION OF PARKS & RECREATION

12. SPRING CREEK GOLF COURSE UPDATE - DAY 1, 2:10:34 MARK

Scott Simpson, Parks Director, gave a verbal update virtually on the meeting that happened on August 30, 2022, at the Outdoor Campus – Sioux Falls with the homeowners' associations from the Spring Creek Golf Course area.

13. RECREATIONAL TRAILS PROGRAM - DAY 1, 2:46:45 MARK

Randy Kittle, Grant & Loan Specialist, gave a verbal update virtually on the Recreational Trails Program. These funds are part of the gas tax in the Transportation Bill. The RTP Advisory Committee met on June 7, 2022, to review applications and make funding recommendations. The committee recommended funding \$684,278 in motorized projects and \$1,596,649 in nonmotorized projects.

14. FEMA UPDATE - DAY 1, 2:52:35 MARK

Travis Theilen, Planning and Development Division Staff Specialist, gave a virtual presentation to the commission on the progress made from the 2019 disasters, with over 75% of the damages having undergone repairs within the first three years. Several options exist for SD GFP (as an applicant for public assistance) to match a reasonable repair to eligible damages. The 2022 disaster event that resulted in severe tree damage and minor facility damage required crews to respond and conduct debris removal activities immediately. An inventory of damages is collected from GFP staff and will be used to apply for FEMA-eligible public assistance.

15. BECOMING AN OUTDOOR FAMILY WORKSHOP UPDATE - DAY 1, 3:50:36 MARK

April Larson, Marketing Coordinator, reported 2022 Becoming an Outdoor Family three-day workshop was held at Pelican Lake Recreation Area near Watertown on July 27-29. This annual education program encourages families to try new recreation activities, build confidence in their outdoor skills, and meet others with shared interests. Over 50 participants, including numerous multi-generation and blended families, traveled across the state. For most, this was their first workshop and camping experience at Pelican Lake Recreation Area. Staff was available throughout the workshop to help set up tents, host group dinners, and teach classes. This year's class topics included archery, air gun, birding, paddling, fishing, geocaching, photography, plants, tracks, Dutch oven cooking, trapping, and deer and waterfowl hunting lectures. The overwhelming response from families is that they had a great time and learned a lot from all the Conservation Officers, Biologists, Park Managers, Interns, and other South Dakota Game, Fish and Parks staff that took the time to share their knowledge. Registration for the next workshop will open in the spring of 2023.

16. FALL PROGRAMMING AND SPECIAL EVENTS UPDATE - DAY 1, 3:54:06 MARK

April Larson, Marketing Coordinator, gave a virtual verbal update on the upcoming planned events for this fall in the state parks, such as the Governor's Buffalo Roundup, fall festivals, and hikes.

17. FEDERAL BRIDGE PROGRAM UPDATE - DAY 1, 4:00:07 MARK

Adam Kulesa, Planning & Development Coordinator, provided a virtual presentation outlining the Federal Bridge Program and how it affects the department. 4 Bridges have been accepted into the cost-share program and are scheduled to be replaced in the fall of 2024 (three within Custer State Park and one at Bear Butte State Park).

18. JULY CAMPING, VISITATION, AND REVENUE REPORT - DAY 2, 00:03:10 MARK

Al Nedved, Parks Deputy Director, provided documentation and reported verbally on the July 2022 camping, visitation, and revenue report.

DIVISION OF WILDLIFE

19. ELK CONTINGENCY LICENSES - DAY 2, 00:34:27 MARK

Andy Lindbloom, Senior Big Game Biologist, gave a virtual presentation to the commission concerning the Elk Contingency Licenses. NRCS, USFS, and GFP meet twice a year to discuss range conditions. Based on recommendations provided as part of the Forage Production Model, the department is recommending Elk Unit 2B be granted five licenses, Unit 2HIJ be granted five licenses, Unit 3BCD be granted seven licenses, and Unit 7B be granted five licenses for a total of 22 Antlerless Elk Contingency Licenses.

Motioned by Bartling, seconded by Rissler to issue twenty-two Antlerless Elk Contingency Licenses in the department recommended elk units. Voting for the motion: Spring, Bartling, Rissler, Locken, Whitmyre & Olson. Voting in opposition to the motion: Bies. Motion carried.

20. GROUSE MANAGEMENT PLAN - DAY 1, 3:11:32 MARK

Alex Solem, Wildlife Biologist, and Hilary Morey, Senior Wildlife Biologist, gave a joint presentation stating South Dakota has two species of prairie grouse, the sharp-tailed grouse, and the greater prairie-chicken, which are native to grassland habitats and require extensive, intact grasslands to persist. Prairie grouse management heavily depends on retaining and maintaining existing grasslands in South Dakota. A system of priority habitat areas was generated from a spatially explicit habitat-based occupancy model to direct management actions to areas identified as essential habitats to prairie grouse. These management efforts should focus on proper grazing regimes, restoration and maintenance of grasslands, and the removal/prevention of tree encroachment.

21. LAKE STURGEON PROGRAM UPDATE - DAY 2, 00:58:53 MARK

Chelsey Pasbrig, Aquatic Biologist, gave a virtual presentation regarding the Big Stone Lake (border water with MN) historically housed a wild population of Lake Sturgeon, present up until the mid-1900s, with the last fish being washed up on shore in 1946. Since the 1980s, considerable work to improve water quality and make the habitat more suitable for Lake Surgeon has been completed on the Little Minnesota River, Minnesota River, and Big Stone Lake. In 2014, a Lake Sturgeon stocking program began on Big Stone Lake, which has continued to date, stocking just over 34,000 fingerlings, with successful incidental catches by anglers (catch and release only), commercial fishermen, and standard lake surveys. This spring, there were reports of congregations of Lake Sturgeon within the Whetstone River near Madison. To date, the reintroduction efforts have shown great promise for the potential of a future fishery; however, further habitat improvements will be needed to help restore the essential spawning habitat of this prehistoric fish.

22. NONRESIDENT ARCHERY DEER & ANTELOPE - DAY 2: 01:18:51 MARK

Tom Kirschenmann, Wildlife Director, verbally updated the Commission on the plan to work with interested agencies to establish a Public Input Forum that will study the department's nonresident archery deer and antelope licensing program. The department is finalizing the short public survey to be sent out this month to current deer and antelope hunters, which the Public Input Forum will explore. Once this is complete, the department will return with recommendations from this forum to the commission in December.

23. SIOUX FALLS OUTDOOR CAMPUS UPDATE - DAY 2, 00:10:10 MARK

Emmett Keyser, Regional Supervisor, gave a verbal update concerning the 25th Celebration of the Sioux Falls Outdoor Campus and Expansion project. On August 30th, more than 100 enthusiastic supporters of the Sioux Falls Outdoor Campus gathered at an event hosted by the Friends of the Outdoor Campus Committee to celebrate the campus programs' many successes since Game, Fish and Parks opened the doors to the facility in 1997. Governor Kristi Noem joined the list of speakers at the celebration event by outlining the Campus' critical mission of helping to maintain South Dakota's rich outdoor heritage by introducing young people as well as adults to the myriad of outdoor recreational opportunities available across the state, including hunting, fishing, camping, boating, kayaking, hiking, rock climbing, bird, watching, and many, many others. The Governor also surprised the group by presenting GFP Secretary Robling with an Executive Proclamation that cited August 30, 2022, as 'Sioux Falls Outdoor Campus Day' as she highlighted the Campus' delivery of more than 19,800 outdoor skills

education programs that included more than 500,000 participants since 1997. The Governor and others on the speaking program also recognized the numerous donors and supporters the Sioux Falls Outdoor Campus has had over the years, including the nearly 1,250 volunteers who have provided more than 123,000 hours of service in support of the Campus' mission and programming. The event also highlighted the fundraising kickoff led by the SD Parks and Wildlife Foundation, which will gather donor funds to help provide for increased programming space for the Outdoor Campus. This expansion will include an indoor archery range, an outdoor archery range, two classrooms, a game processing area, a redesign of a classroom to enable wild fish and game cooking programs, and the development of new wildlife displays in the Gallery area.

Proposed changes:

- 1. Current administrative rule does not allow for pets in department camping facilities except under certain circumstances.
- 2. The proposed rule change would allow for customers to pay a pet fee and have their pet stay in the cabin or suite.

SUPPORTIVE INFORMATION

Pet ownership continues to increase. Accommodations for pets in the travel industry has become a standard practice. This rule change would allow those people staying in a cabin, lodge, or suite within a state park to have their pet inside that facility during their stay. A pet accommodation fee of \$10 per reservation per facility is provided for in a separate proposal.

DRAFT ADMINISTRATIVE RULE CHANGES

The following are proposed draft changes that are intended to incorporate the recommended changes adopted by the Commission.

41:03:01:13. Pet prohibitions. A person may not allow or possess any pet in the state park system except as provided in this section:

- (1) From April 1 through September 30, the pet must be under immediate control on a leash not more than 10 feet long or under immediate control and more than 200 feet from other park users or designated camping areas;
- (2) From October 1 through March 31, leashes are not mandatory; however, the person shall keep the pet under immediate control;
- (3) The person may not allow or possess any pet on the Summit Trail at Bear Butte State Park;
- (4) The person may not allow or possess any pet on the George S. Mickelson Trail unless the pet is under immediate control on a leash not more than 10 feet long;
- (5) The person may not allow any pet in an area within 200 feet inland and 200 feet outward from the water's edge in an area owned, leased, managed, or controlled by the department and designated as a public swimming zone or in an area posted for no pets;

- (6) The person may not allow or possess any pet inside enclosed public buildings managed by the department in any state park, recreation area, nature area, or lakeside use area except:
 - (a) a A person who requires the aid of a service animal;
 - (b) or a A person who has received prior approval of the park manager; or
 - (c) a person who has paid the pet accommodation fee pursuant to 41:03:04:03.02.
- (7) The person shall properly dispose of any pet waste left within the state park system; or
- (8) If the person maintains reasonable control of the dog, the person may allow or possess a dog that is not on a leash within a designated dog training area.

FISCAL IMPACT

This allowance and associated fee are intended to be in line with industry standards and to offset some of the additional cleaning fees expected with allowing pets in lodging facilities. The percentage of users that will utilize this service is unknown. The revenue generated nor additional expense is expected to have any significant impact on the Department's budget.

41:06:13:01. Spring wild turkey hunting season established -- Number and type of licenses available. The spring prairie wild turkey hunting season is open from one-half hour before sunrise to sunset each day from the first second Saturday of April through May 31. The spring Black Hills wild turkey hunting season is open from one-half hour before sunrise to sunset each day from the fourth Saturday of April through May 31. The spring archery and mentored wild turkey hunting seasons are open from on-half hour before sunrise to sunset each day and the season dates align with the prairie and Black Hills, respectively. , in Unit AST-ST1, and from one-half hour before sunrise to sunset each day from the second third Saturday of April through May 31, or as otherwise provided in § 41:06:13:02, in all other units. Units BST-BH1 is and BST-BH2 are the Black Hills units. Unit AST-ST1 is the archery unit. All other units are prairie units. The number of one-tag male turkey licenses issued is unlimited for residents and nonresidents in both the Black Hills and archery spring turkey hunting seasons. No more than 5,807 10,000 one-tag male turkey and 600 2,500 two-tag male turkey licenses may be issued to residents for the prairie spring turkey hunting season.

41:06:13:02. Open units -- Exceptions. The following is a description of the open spring turkey hunting units:

- (1) Unit BST-BH1: excluding Custer State Park, Wind Cave National Park, Mount Rushmore National Memorial, and Jewel Cave National Monument, that portion of Lawrence County south of Interstate 90; that portion of Meade County west and south of Interstate 90; those portions of Pennington and Custer Counties west of State Highway 79; that portion of Fall River County north and west of a line beginning at the junction of the South Dakota-Wyoming border and U.S. Highway 18, then east along U.S. Highway 18 to its junction with the Cheyenne River, then east along the Cheyenne River to its junction with State Highway 79, then north along State Highway 79 to its junction with the Custer County line;
 - (2) Unit BST-BH2: the same boundaries as Unit BST-BH1; Unit BST-BH2 is closed;
- (7) Unit PST-08A: Davison and Hanson Counties; Unit PST-08A is open beginning on the second Saturday of April through April 30;
- (8) Unit PST-08B: Davison and Hanson Counties; Unit PST-08B is open beginning on May 1 through May 31;
- (33) Unit PST-44A: Lincoln County; Unit PST-44A is open beginning on the second Saturday of April through April 30;
 - (34) Unit PST-44B: Lincoln County; Unit PST-44B is open beginning on May 1 through May 31;
- (43) Unit PST-58B: that portion of Stanley County located at the Oahe Downstream Recreation Area to include the U.S. Army Corps of Engineers Land which is east and southeast of Powerhouse Road. This unit is bordered by the Missouri River to the east and the emergency spillway canal to the south. Unit PST-58B-is open beginning on through April 30, but only to licensed persons who use a wheelchair;

<u>Licensees</u> <u>Excluding that portion of Fall River County within Unit PST-27A, licensees</u> in prairie units that utilize the Cheyenne or White Rivers as unit boundaries may hunt within one mile of either side of the river boundary, as well as in the remainder of the unit for which the license is issued.

- **41:06:13:04. Application requirements and restrictions.** The following apply to all applications for license and licenses issued under this chapter:
- (1) A resident may apply for no more than one prairie unit license, one Unit BST-BH1 license, one Unit BST-BH2, and one Unit AST-ST1 license during the first license application period. A resident

may not apply for or receive more than one Unit BST-BH1 license, one Unit BST-BH2, or one Unit AST-ST1 license;



The public hearing is to consider adoption, amendment, and repeal of Rules pertaining to:

1. ARSD 41:03:01:16. Restrictions on use of firearms, air guns, crossbows, and bows in the state park system -- Exceptions.

Effect: Modify the time during the season when hunters can have uncased weapons within certain parks in the state park system.

Reason: The objectives are to increase turkey population performance and to increase hunter satisfaction with a later start date to the season.

2. ARSD 41:06:13:01. Spring wild turkey hunting season established -- Number and type of licenses available.

Effect: Changes the start date of the spring turkey hunting season and increases the maximum number of licenses available to residents.

Reason: Turkey population status is monitored based on harvest success in most units across South Dakota but based on recent research we are not observing the reproduction level desired in the central and northern Black Hills and a few prairie units. In addition, negative feedback from hunters and their hunting experience led to the justification for these proposed changes. The objectives are to increase turkey population performance and increase hunter satisfaction with a later start date to the season.

3. 41:06:13:02. Open units – Exceptions (Turkey).

Effect: The proposed change would modify the hunting units within the Black Hills.

Reason: With a shortened season and increasing sales of unlimited archery turkey

licenses, it is difficult to justify this second turkey license for residents in the future. The objectives are to increase turkey population performance and increase hunter satisfaction with a later start date to the season.

4. ARSD 41:06:13:04. Application requirements and restrictions.

Effect: Removes a unit from the spring wild turkey hunting season and revises the valid date of access permits for Good Earth State Park and Adams Homestead and Nature Preserve.

Reason: The objectives are to increase turkey population performance and increase hunter satisfaction with a later start date to the season.

5. ARSD 41:06:13:05. Turkey hunting recruitment license – Open area and eligibility.

Effect: The proposed change will align start dates for this season with other turkey season start dates.

Reason: The proposed change will align turkey hunting recruitment season start dates with current proposed spring turkey season start dates. The objectives are to increase turkey population performance and increase hunter satisfaction with a later start date to the season.

6. ARSD 41:06:15:01. Spring wild turkey hunting season established – Number and type of licenses available.

.Effect: Establishes a later Custer State Park spring wild turkey season and sets the number of available licenses to residents.

Reason: Turkey population status is monitored based on harvest success in most units across South Dakota but based on recent research we are observing the reproduction level desired in the central and northern Black Hills and a few prairie units. In addition, negative feedback from hunters and their hunting experience led to the justification for these proposed changes. The objectives are to increase turkey population performance and increase hunter satisfaction with a later start date to the season.

7. ARSD 41:06:15:02. Open unit (turkey).

Effect: The proposed change would remove the preference point unit from turkey hunting in Custer State Park.

Reason: This preference point unit is no longer needed and applicants will still have the option to purchase preference within the licensing system.

In the July 2022 Commission Meeting a proposal was brought forth to modify the Turkey season by decreasing it by one week. The reasoning behind this is supported by low reproduction levels in the Black Hills. The comments at the bottom of the proposal state, "Turkey populations are thriving across most of South Dakota", so why are we looking to decrease the season statewide instead of supporting a change in a very specific area. Adjusting the season state wide could lead to turkey over burden in areas that are currently thriving. South Dakota has many topographical variations and more than one variety or turkey. Managing the entire turkey population across the state in the same manner is like managing the lakes in South Dakota the same with out regard to the variance of what each body of water can support. Rejecting this proposal offers SD GFP the opportunity to come back with hard numbers to support change in both license numbers and season dates within a location instead. South Dakota has a variety of turkeys and the turkey burden from one area to the next can vary significantly. Proposing license restrictions may be necessary at times, but it is detrimental to make changes to an entire season state wide without regard to the topographical variation, game volume, and subspecies variation in South Dakota.
