primarily from the sale of hunting licenses. Hunting is also recognized as the most effective and cost efficient method to manage populations					
and minimize damage. For these reasons and considerations received by GFP, the Producer agrees to allow reasonable, free public hunting access to non-family members who obtain proper permission.					
6. The Producer agrees NOT to charge any person or entity a fee or payment for hunting access for deer and/or elk (i.e. specific to the					
species which is causing the depredation problem).  7. The Producer agrees to allow GFP employees the right to access said property for inspection and verification of contract provisions.					
8. Change in ownership of the contracted area or failure to comply with the provisions of the contract shall be cause to terminate this agreement.					
In addition to termination of the agreement, any unused materials and unearned payments shall be returned to the department.  9. The Producer agrees to hold harmless and indemnify the State of South Dakota, its officers, agents, and employees, from and against any and					
all actions, suits, damages, liability, or other proceedings which may arise as the result of the negligence, misconduct, error or omission of					
Producer or any officer, agent, or employee of Producer.  10. By entering into the terms of this agreement, the Producer understands and acknowledges that the State of South Dakota assumes no					
financial obligation, responsibility, or liability for any damage or damages caused by free-roaming wild animals.
