This petition was received from landowners Jeff and Wendy Hanson of Watertown, South Dakota.

In accordance with SDCL 41-23-9 and South Dakota Administrative Rule 41:04:06, a petition dated November 7, 2017 requests the closure of a portion of Goose Lake to recreational use, to include, boating, fishing, hunting, trapping, ice fishing, diving, and driving. A hearing will take place at 10:00 am (MDT) on April 6, 2018 at Outdoor Campus West, 4130 Adventure Trail, Rapid City, South Dakota.

This hearing is an adversary proceeding held in accordance with SDCL 1-26. Any interested party who wishes to be a part of this hearing shall give notice to this office no later than March 28, 2018 by submitting notice to jon.kotilnek@state.sd.us. If notice is not received March 28, 2018, there is no guarantee that interested persons will be heard at the hearing. The Commission will exercise, at their discretion, whether interested parties who have not met the deadline will be heard at the hearing. Interested persons, who have met the timeline, will be given reasonable opportunity to submit data, opinions, arguments, and their views, either orally or in writing (or both) at the hearing. All interested parties have the right to be heard at the hearing and/or to be represented by a lawyer. The decision of the commission may be appealed to the Circuit Court and the State Supreme Court as provided by law. Special notice is given that if an interested party is a corporation or LLC, they must be represented by legal counsel at contested case hearings.
