NOTICE OF PUBLIC HEARING DEPARTMENT OF GAME, FISH AND PARKS

A Public Hearing will be held at the Good Earth State Park, 26924 480th Avenue, Sioux Falls, SD 57108 at 2:00 pm (Central Time) on Wednesday, August 31, 2022. Individuals wishing to participate may attend in person or by teleconference. Teleconference information can be found at https://gfp.sd.gov/commission/information/. The public hearing is to consider adoption, amendment, and repeal of Rules pertaining to:

1. ARSD 41:03:01:16. Restrictions on use of firearms, air guns, crossbows, and bows in the state park system -- Exceptions.

Effect: Modify the time during the season when hunters can have uncased weapons within certain parks in the state park system.

Reason: The objectives are to increase turkey population performance and to increase hunter satisfaction with a later start date to the season.

 2. ARSD 41:06:13:01. Spring wild turkey hunting season established -- Number and type of licenses available.

Effect: Changes the start date of the spring turkey hunting season and increases the maximum number of licenses available to residents.

Reason: Turkey population status is monitored based on harvest success in most units across South Dakota but based on recent research we are not observing the reproduction level desired in the central and northern Black Hills and a few prairie units. In addition, negative feedback from hunters and their hunting experience lead to the justification for these proposed changes. The objectives are to increase turkey population performance and increase hunter satisfaction with a later start date to the season.

3. ARSD 41:06:13:02. Open units -- Exceptions.

Effect: Modifies the season dates for those hunting units with split seasons and

eliminates a hunting unit from the Black Hills.

Reason: With a change to the start date for all turkey seasons, allocation of time to those units with split seasons needed to be adjusted. With a shortened season and increasing sales of unlimited archery turkey licenses, it is difficult to justify this second turkey license for residents in the future. The objectives are to increase turkey population performance and increase hunter satisfaction with a later start date to the season.

4. ARSD 41:06:13:04. Application requirements and restrictions.

Effect: Removes a unit from the spring wild turkey hunting season and revises the valid date of access permits for Good Earth State Park and Adams Homestead and Nature Preserve.

Reason: The objectives are to increase turkey population performance and increase hunter satisfaction with a later start date to the season.

5. ARSD 41:06:13:05. Turkey hunting recruitment license – Open area and eligibility.

Effect: The proposed modification will change the turkey hunting recruitment season to the "third" Sunday of April instead of the "first" Sunday of April.

Reason: The proposed change will align turkey hunting recruitment season start dates with current proposed spring turkey season start dates. The objectives are to increase turkey population performance and increase hunter satisfaction with a later start date to the season.

 ARSD 41:06:15:01. Spring wild turkey hunting season established – Number and type of licenses available.

.Effect: Establishes a later spring wild turkey season and sets the number of available licenses to residents.

Reason: Turkey population status is monitored based on harvest success in most units across South Dakota but based on recent research we are observing the reproduction level desired in the central and northern Black Hills and a few prairie units. In addition, negative feedback from hunters and their hunting experience led to the justification for these proposed changes. The objectives are to increase turkey population performance and increase hunter satisfaction with a later start date to the season.

7. ARSD 41:06:15:02. Open unit (turkey).

Effect: The proposed change would remove the preference point unit from turkey hunting in Custer State Park (CSP).

Reason: This preference point unit is no longer needed and applicants will still have the option to purchase preference within the licensing system

8. ARSD 41:07:01:16. Ice fishing shelter removal deadlines.

Effect: Removes the deadline for removing ice shacks from the ice each year.

Reason: Removing deadline would allow anglers to keep shelters in place during years when suitable ice conditions still exist past the previous deadline. Additionally, it would provide flexibility for anglers when access conditions prohibit retrieval of shelters.

9. ARSD 41:07:01:17. Liberalized take of silver carp, bighead carp, smelt, and lake herring.

Effect: Removes restrictions on mesh size or net size for nets used for taking smelt.

Reason: Restrictions on mesh size or net size for taking smelt were the same as for taking noncommercial bait using minnow traps, seines, dip nets, lift nets, or cast nets. Net restrictions for take bait for noncommercial use were removed for 2022.

10. ARSD 41:07:03:03. Daily, possession, and length limit restrictions on special management waters.

Effect: Proposed changes would remove the 15-inch minimum length limit for bass on Burke Lake (Gregory County) and impose a 15-inch minimum length limit on Lake Mitchell (Davidson County). Reason: The regulation is not needed on Burke Lake and will protect smaller largemouth bass from harvest on Lake Mitchell resulting in increased abundance and improved sizes of bass.

11. ARSD 41:07:05:02. Paddlefish season in special management areas.

Effect: Allow crossbows as a legal method of take for paddlefish during seasons when bow and arrow are a legal method of take and match areas where crossbows can be used to take paddlefish below Gavins Point Dam with Nebraska regulations. Additionally, language regarding purchasing preference points associated with the old GFP licensing system would be removed.

Reason: Allowing crossbows and modifying boundaries would also align with Nebraska border waters and increase opportunity. This preference point unit language is no longer needed and applicants will still have the option to purchase preference within the licensing system.

12. ARSD 41:07:08:05. Use of another person's hoop nets, traps, setlines, or floatlines.

Effect: Allowing someone else to help tend hoop, trap, setlines and floatlines if the licensee is present.

Reason: Allowing someone to assist a licensee with tending their equipment would increase opportunity when using these gears, clarify rule language for enforcement purposes, and be beneficial for licensees with mobility issues.

13. ARSD 41:07:08:05.02. Tending hoop nets, traps, setlines, and floatlines.

Effect: Reduce check times for hoop nets, traps, and setlines.

Reason: Modifying the check time for hoop nets, traps, and setlines would reduce bycatch and mortality of non-targeted species, such as turtles. Additionally, this change would align South Dakota regulations with Nebraska. 14. ARSD 41:09:08:03.04. Importation requirements for fish or fish reproductive products.

Effect: Modify the rule listing fish importation requirements to better describe current definitions.

Reason: Current language needs to be modified to match language used to describe fish diseases.

15. ARSD: 41:09:12:08 Disabled angler assistance permit. (New Rule)

Effect: The new rule would allow permitted individuals to receive assistance when participating in lawful fishing activities.

Reason: Creating a disabled angler assistance permit would allow for users who have disabilities that affect their ability to fish to receive assistance from another individual to perform lawful fishing activities.

16. ARSD 41:10:02:01. List of endangered birds.

Effect: Remove the Peregrine Falcon (*Falco peregrinus*) from the endangered list of state threatened and endangered bird species.

Reason: Results from a State Threatened and Endangered Species Status Review indicate that the peregrine has met the criteria to downlist the species from endangered to threatened.

17. ARSD 41:10:02:02. List of threatened birds.

Effect: Add the Peregrine Falcon (*Falco peregrinus*) to threatened on the list of state threatened and endangered bird species.

Reason: Results from a State Threatened and Endangered Species Status Review indicate that the peregrine has met the criteria to downlist the species from endangered to threatened.

Interested persons will be given reasonable opportunity to submit data, opinions, arguments, and their views, either orally or in writing (or both) at the hearing. Commissioners:

I am writing in <u>OPPOSITION</u> to a majority of the proposed Spring Turkey changes. Please see my replies below in the **bold blue text**.

1. Modify the season dates for all spring turkey hunting seasons to begin on the third Saturday of April and end on May 31.

I support moving the firearms season back a week however I do not agree with removing the week earlier start for archery hunters.

2. Adjust the maximum number of licenses available in administrative rule from no more than 5,807 to 10,000 one-tag "male turkey" licenses and from no more than 600 to 2,500 two-tag "male turkey" licenses.

Oppose. If the goal of these changes is to grow/maintain the statewide turkey population, how does increasing the number of tags +10% by 2023/2034 help achieve that goal? I don't agree with increasing tags if we are consolidating the season into a smaller window of time. It will produce overcrowding on public land and potentially increase the likelihood of in the field firearm accidents, which sadly are becoming more and more common in turkey seasons due to increased interest in "fanning" or "reaping" turkeys with tail fans.

3. Eliminate Unit BST-BH2, which provides for a second Black Hills spring turkey licenses for resident hunters.

Support. Limiting tags in a unit where populations are declining makes sense. I would be happier if there would be a cap on Black Hills tags for both residents and nonresidents.

4. Modify the season dates for those prairie units with split season seasons.

No opposition.

5. Modify the valid time during the season when access permits are valid for Good Earth State Park and Adams Homestead and Nature Preserve.

No opposition.

6. Modify the valid time during the season when hunters can have uncased weapons within the boundary of Sica Hollow State Park.

No opposition.

While I am not excited about potentially losing two weeks of turkey season, I understand to a point the reasoning. My only concern is that shortening the season but increasing the number of tags will produce overcrowding on public lands and decrease overall hunter satisfaction and the quality of season.

Chairman Olson and Members of the South Dakota Game, Fish, and Parks Commission,

Further, we strongly support wildlife management decisions based on the best available science. We have reviewed the current proposal from SDGFP staff to change the season structure for the 2023 Spring wild turkey season, specifically recommendations to delay the opening date by one week from Its current structure. Additionally, we have reviewed the data presented to the Commission at the July meeting by SDGFP staff Chad Lehman. We support the SDGFP proposal to move the spring turkey season opener to the third Saturday in April to better correlate with peak nest incubation dates. Doing so should have positive impacts on the overall health of South Dakota's wild turkey population and potentially lead to an increase in hunter satisfaction.

Additionally, and again based on the data provided by SDGFP staff on current wild turkey populations, we would ask the Commission to consider delaying the Spring turkey season opener another week to the fourth Saturday in April. We recognize this is a more conservative approach than the current staff proposal but believe it warrants your consideration for the potential long-term impacts to South Dakota's wild turkey population. We believe delaying the season dates to better correlate with the data currently available on wild turkey population trends will have the greatest benefit to the resource while maximizing hunter opportunity and satisfaction.

We greatly value our partnership with SDGFP and the hard work of your staff to manage the wild turkeys in the state. We appreciate SDGFP staff's commitment to let the science lead management decisions and adjust hunter opportunity to maximize the resource. Finally, we appreciate the Commission and your hard work and the opportunity to provide comment on the SDGFP proposal for the 2023 Spring wild turkey season. Dear Commissioners,

Lake Mitchell Bassmasters support the proposal to reinstate the 15-inch minimum length limit on largemouth and smallmouth bass in Lake Mitchell, Davison county.

One purpose of Lake Mitchell Bassmasters club is to protect, conserve and sustain the black bass fishing resource for all anglers. For many years, Lake Mitchell Bassmasters has been involved in habitat projects at Lake Mitchell and teaching young anglers fishing skills. In early 2001 our club decided to do a project to help correct the declining trajectory of the Lake Mitchell Bass Population. Dave Lucchesi, the GFP East Region Fisheries Supervisor and biologist has been very helpful listening to our concerns and helping us understand how we can best help the fishery.

For several years, Lake Mitchell Bassmasters has noticed a considerable decline in the largemouth bass population. This is evidenced by 10 years of declining summer-league catch data. Anglers not only seeing fewer adult largemouth and smallmouth, but also reporting very few catches of small largemouth. Also, the last 4 GFP monitoring efforts on the lake from 2016 to 2022 showed catch rates of less than five largemouth per hour. Compared to an average catch rate of nearly 24 largemouth per hour from 1994 through 2012. The GFP management objective for the lake is to maintain a largemouth bass fishery with an electrofishing CPH of at least 20 stock length fish (eight inches or greater) and an RSD-P range of 20-40. Lake Mitchell Bassmasters is grateful the GFP has this fair objective and their plans to annually monitor the largemouth population.

Reasons for the decline are suspected but not well understood. High predation of young of year bass by abundant black crappie and now bluegill have suppressed largemouth recruitment. Black crappies recently have supported a popular fishery, and anglers targeting crappies may have also harvested incidentally caught small largemouth not protected under a minimum length limit.

Re-instating the length limit will give the bass population a chance to rebuild and protects the current and potential future investment the Game Fish and Parks makes for supplementing the bass population with smaller largemouth. Additionally, a length limit will help to alleviate bass anglers concerns with the current state of the lake and as Lake Mitchell goes through the planned improvement project in the future. As advocates for fish habitat, Lake Mitchell Bassmasters will be in alliance with the Game Fish and Parks. Thank-you commissioners for considering this proprosal.

18. Spring Wild Turkey Hunting Season

41:06:13:05. Turkey hunting recruitment license – Open area and eligibility. The turkey hunting recruitment licenses are valid statewide, excluding Custer State Park, from one-half hour before sunrise to sunset beginning on the first Saturday of April through May 31 during the spring turkey hunting seasons. A person is eligible as provided in SDCL 41-6-81.

41:06:13:06. Number and types of licenses available -- Application process. A sponsoring nongovernmental organization shall complete and apply to the department stating the name, address, and phone number of the sponsoring organization. No more than 10 male turkey hunting recruitment licenses may be issued with no more than two of the allocated licenses issued per sponsoring nongovernmental organization. The sponsoring non-governmental organization shall be responsible for license fees.

41:06:13:07. Criteria for selection by commission of non-governmental organization. Any nongovernmental organizations devoted to wildlife management; preservation; propagation; habitat; research; hunter retention, recruitment, and reactivation; and recognized as an exempt organization under § 501(c)(3) of the United States Internal Revenue Code may apply for such licenses.

41:06:13:08. Application deadline. The completed application under §41:06:13:06 must be received by the department by December 31 preceding the spring turkey season.

41:06:13:09. Selection of non-governmental organization by commission. The commission shall review and evaluate the information contained in the applications according to the criteria listed in §41:06:13:07 and shall select the participants it considers best qualified. The department secretary shall notify all applicants regarding the commission's selection.

Department recommended changes from Proposal: None

Motioned by Rissler, seconded by Bartling to APPROVE THE FINALIZATION OF CHANGES TO CHAPTER 41:06:13. Motion carried unanimously.

DIVISION OF PARKS & RECREATION (continued)

20. PARK FEE REVIEW PROCESS

Director Simpson and his team performed an annual review and there will be no need to park fee changes at this time.

21. AMERICAN RESCUE PLAN ACT UPDATE

Adam Kulesa, Planning/Development Administration, provided a short presentation regarding the history and current status of the ARPA funding for the department. 17 million dollars has been allocated by the state legislature for over 50 water and sewer infrastructure projects across the state. A couple questions were asked by the commission in regard to the type of projects, prioritization, and park impact. Staff were able to provide answers and ensure the public we will prioritize larger dollar projects that are challenging to fund through our capital development budget and projects will primarily be completed in the shoulder/off seasons to ensure minimal disruption to park use. Funds are required to be spend by the end of the 2026 federal fiscal year.

22. HIDDENWOOD PARK UPDATE

Dan Richards, Park Manager, shared a presentation explaining the accomplishments in the last four years that paved the way for the re-opening of Lake Hiddenwood Recreation Area. Also highlighted were partnerships that were fostered including the close relationship with the Lake Hiddenwood Foundation. With the help of private donations, generous contractors and volunteer efforts who donated time and equipment the park was able to fund the building of a new access road back into the park. A couple questions were asked by the commission in reference to camping since the reopening and future plans for lakebed. Currently the campground has available campsites as electrical services has yet to be restored and work also continues on hiking bridges and trails. Plans down the road include the development of a fishery again.

23. LAKE OAHE BOAT ACCESS UPDATE

Adam Kulesa, Planning/Development Administration, provided a short presentation updating the Commission on lake levels of Lake Oahe and how they may affect access. Access projects that have been complete and those on our radar to monitor were explained and the commission did not have any questions.

24. FORT SISSETON FESTIVAL RECAP

Ali Jo Tonsfeldt, Park Manager, gave a presentation on the recent festival held at Fort Sisseton.

25. PALISADES STATE PARK UPDATE

Director Simpson informed the board a bid had gone out in May to put in water lines, construction of comfort station and welcome center estimated at 3.7 million dollars. Bids came back over the estimate due to increase in supply costs. Parks crew is working out how to lower the bid. Ultimately, they rejected submitted bids and are working to change bid packages. This moves anticipated campground opening back. Looking at potential construction next spring.

26. STORM DAMAGE UPDATE

Director Simpson informed the Commission of parks that had been affected by recent storm damage and repairs being made.

27. JUNE CAMPING, VISITATION AND REVENUE REPORT

Director Simpson provided the Commission with the June 2022 Visitation by District report for their review.

DIVISION OF WILDLIFE

28. Elk Raffle License

Director Kirschenmann informed the Commission of the Rocky Mountain Elk Foundation would like to again raffle off a Resident Only Elk License in Custer State Park.

Motioned by Bies, seconded by Bartling to approve the Rocky Mountain Elk Foundation one resident only elk license to be raffled off. Motion carried unanimously.

29. NEST PREDATOR BOUNTY PROGRAM SUMMARY

Jacquie Ermer, Program Manager, reported this is the fourth year of the Nest Predator Bounty Program. New this year, only youth under the age of 18 were eligible to participate during the month of March. Starting April 1, the program was opened for all age participants. Eligible tails were \$10 each. The \$500,000 maximum was reached on the last day, July 1. Nearly 55,000 tails were submitted for the 2022 program with raccoon making up 73% of all submissions followed by striped skunk at 13%. About 2,400 individuals participated which is 14% less than in 2021. Approximately 32% of all participants were under 18 years of age. Sixteen youth participants were drawn for the weekly prize giveaway package. GFP and partners continue to offer trapping-based education classes to promote ethical and safe take.

30. RIVER OTTER SEASON & HARVEST HISTORY

Alex Solem, Wildlife Biologist, reported a total of 21 river otters were harvested during the 2021 river otter hunting/trapping season. South Dakota Game, Fish and Parks biologists use multiple methods in managing river otter populations throughout the river otter management zone. Biologists use trend data from a catch-per-unit index derived from surveying successful trappers. Biologists also conduct stream surveys within the Big Sioux River utilizing non-invasive genetic sampling by collecting genetic material from scat and anal jellies found on communal latrines. Biologists plan on developing an index to abundance using this number of identified individuals. Biologists also use trend data associated with opportunistic reports of sign and sightings, number of incidental catches, and road kills. Carcasses from all legal harvests, incidental catches, and road kills are necropsied to collect demographic data on those individual river otters to give additional insight in the population status.

31. WILDLIFE ACTION PLAN REVISION

Eileen Dowd Stunkel, Senior Wildlife Biologist, reported the South Dakota's Wildlife Action Plan allows Game, Fish and Parks to remain eligible to receive a Congressional appropriation called State Wildlife Grants. These funds help implement the state's Wildlife Action Plan, a strategic plan to address the needs of fish and wildlife species and the habitats they need. This annual appropriation is unstable and inadequate to meet state funding needs. A new legislative opportunity called Recovering America's Wildlife Act (RAWA) has passed the U.S. House and awaits a floor vote in the U.S. Senate. This bill would provide an estimated \$17 million per year to GFP to help implement the SD Wildlife Action Plan. GFP has begun a minor plan revision to add plant species of greatest conservation need and additional animal species to the Plan to be eligible for RAWA funds when they are available. This will be a significant opportunity to allow states and tribes to better address species conservation, with new funding for education, wildlife-associated recreation, and law enforcement related to rare species.

32. OUTDOOR CAMPUS & SDSU COOPERATION POSITIONS

Lacy Elrod, Visitor Services Coordinator, reported the Outdoor Campus and SDSU will cooperatively be hiring two new position to help with youth education.

33. LICENSE SALES UPDATE

Director Kirschenmann provided a brief summary on license sales. Overall, license sales remain strong. Compared to last month's report, license sales have increased. In comparison to the 3-year average, resident license sales are a little behind and nonresident sales are very similar.







SUPPORTIVE INFORMATION

Results from recent research indicates poor reproduction, primarily within the Black Hills (central and northern Hills) but is difficult to ascertain the direct cause/s due to numerous variables involved, such as predation, nutrition, weather, gobbler dominance/behavior. Based on nesting chronology and gobbling activity, the recommendation to start seasons later is to increase population performance. In addition, negative feedback from hunters regarding their hunting experience (i.e., lack of gobbling activity, difficult time finding turkeys) is a justification for this recommendation. See below for other supportive information to justify recommendation:

- Post-breeding management is the primary strategy that should be imposed for wild turkey management (i.e., start spring hunting seasons at median incubation dates).
- Median incubation dates range from May 10-16 in the Black Hills. Many hens start incubation around May 1-3rd in the southern Black Hills.
- Modeling suggests that harvesting ≤30% of the male population allows for continued population growth and higher quality hunting.
- Research in the Black Hills indicates that annual survival of radio-collared adult males was 42% and spring harvest was the primary mortality factor in the Black Hills.
- Intensive hunting in southern Alabama caused a shortage of males and lowered female turkey productivity through infertile clutches.

- Current unpublished research in Georgia and Tennessee indicates dominance hierarchies in adult gobblers may be important in maintaining for turkey productivity. Disruptions in these dominance hierarchies can delay nesting and reduce nest survival in the southeast.
- Harvest management should try to not disrupt breeding of older males until they have a chance to breed which should be around median incubation dates.
- Less than 5% of younger male turkeys will breed under normal dominance hierarchies.

The proposed maximum number of turkey licenses will be established in administrative rule and the GFP Commission via administrative action will determine specific number of licenses by tag types and allocation amongst hunting units.

No more than 200 one-tag male turkey licenses may be issued to residents.

41:06:15:02. Open unit. The following is a description of the open spring turkey hunting unit:

(1) Unit CST-CU1: Custer State Park

(1) Unit CST-CU1-32: A maximum of 100 "male turkey" licenses may be issued for the season;

(2) Unit CST-ZZ-99L: No turkey licenses may be issued. However, an applicant for this unit shall accrue a preference point as provided in § 41:06:01:09.

- 6. A person may use only bow and arrow, a shotgun using shot shells or a muzzleloading shotgun to hunt turkeys during the spring turkey season.

Proposed changes from last year:

- 1. Modify the season dates for all spring turkey hunting seasons to begin on the third Saturday of April and end on May 31.
- Adjust the maximum number of licenses available in administrative rule from no more than 5,807 to 10,000 one-tag "male turkey" licenses and from no more than 600 to 2,500 two-tag "male turkey" licenses.
- 3. Eliminate Unit BST-BH2, which provides for a second Black Hills spring turkey licenses for resident hunters.
- 4. Modify the season dates for those prairie units with split season seasons.
- 5. Modify the valid time during the season when access permits are valid for Good Earth State Park and Adams Homestead and Nature Preserve.
- 6. Modify the valid time during the season when hunters can have uncased weapons within the boundary of Sica Hollow State Park.

DEPARTMENT RECOMMENDATIONS

Recommended changes from proposal:

- 1. Proposed Change #1: Change the proposed season start date from the 3rd Saturday in April <u>to</u> the 2nd Saturday in April for the prairie spring turkey season. This would be a no change to the current administrative rule.
 - a. April 8 May 31, 2023
 - b. April 13 May 31, 2024
- 2. Proposed Change #1: Change the proposed season start date from the 3rd Saturday in April to the 4th Saturday in April for the Black Hills spring turkey season.
 - a. April 22 May 31, 2023
 - b. April 27 May 31, 2024
- 3. Proposed Change #4: Withdraw the proposed changes for the season dates for those prairie units with split seasons. This would be a no change to the current administrative rule.
- 4. Proposed Change #5: Withdraw the proposed changes to modify the valid time during the season when access permits are valid for Good Earth State Park and Adams Homestead and Nature Preserve. This would be a no change to the current administrative rule.
- 5. Proposed Change #6: Withdraw the proposed changes to modify the valid time during the season when hunters can have uncased weapons within the boundary of Sica Hollow State Park. This would be a no change to the current administrative rule.
- 6. For archery and mentored spring turkey licenses, season start dates would align with the prairie and Black Hills season, respectively.
- 7. For the Fall River prairie hunting unit, remove the allowance to hunt within one mile of the Cheyenne River in the Black Hills hunting unit.

SUPPORTIVE INFORMATION

Results from recent research indicates poor reproduction, primarily within the Black Hills (central and northern Hills) but is difficult to ascertain the direct cause/s due to numerous variables involved, such as predation, nutrition, weather, gobbler dominance/behavior. Based on nesting chronology and gobbling activity, the recommendation to start seasons later is to increase population performance. In addition, negative feedback from hunters regarding their hunting experience (i.e., lack of gobbling activity, difficult time finding turkeys) is a justification for this recommendation. See below for other supportive information to justify recommendation:

- Post-breeding management is the primary strategy that should be imposed for wild turkey management (i.e., start spring hunting seasons at median incubation dates).
- Median incubation dates range from May 10-16 in the Black Hills. Many hens start incubation around May 1-3rd in the southern Black Hills.
- Modeling suggests that harvesting ≤30% of the male population allows for continued population growth and higher quality hunting.
- Research in the Black Hills indicates that annual survival of radio-collared adult males was 42% and spring harvest was the primary mortality factor in the Black Hills.
- Intensive hunting in southern Alabama caused a shortage of males and lowered female turkey productivity through infertile clutches.
- Current unpublished research in Georgia and Tennessee indicates dominance hierarchies in adult gobblers may be important in maintaining for turkey productivity. Disruptions in these dominance hierarchies can delay nesting and reduce nest survival in the southeast.
- Harvest management should try to not disrupt breeding of older males until they have a chance to breed which should be around median incubation dates.
- Less than 5% of younger male turkeys will breed under normal dominance hierarchies.

The alignment of all turkey seasons seems appropriate to meet the objectives of the change. Since the elimination of rifles for spring turkey hunting, archers have no disadvantage to shotgun hunters when it comes to the distance, etc. and it's difficult to justify one week only available to archery turkey hunters.

Unit BST-BH2 is currently closed via administrative rule and under the low abundance harvest strategy found within the wild turkey management plan. With a shortened season and increasing sales of unlimited archery turkey licenses, it is difficult to justify this second turkey license for South Dakota residents in the future.

The proposed maximum number of turkey licenses will be established in administrative rule and the GFP Commission via administrative action will determine specific number of licenses by tag types and allocation amongst hunting units.

DRAFT ADMINISTRATIVE RULE CHANGES

The following are proposed draft changes that are intended to incorporate the recommended changes adopted by the Commission.

41:06:13:01. Spring wild turkey hunting season established -- Number and type of licenses available. The spring <u>prairie</u> wild turkey hunting season is open from one-half hour before sunrise to sunset each day from the first <u>second</u> Saturday of April through May 31. The spring Black Hills wild <u>turkey hunting season is open from one-half hour before sunrise to sunset each day from the fourth</u> <u>Saturday of April through May 31. The spring archery and mentored wild turkey hunting seasons are open from on-half hour before sunrise to sunset each day and the season dates align with the prairie and Black Hills, respectively. , in Unit AST-ST1, and from one-half hour before sunrise to sunset each day from the second <u>third</u> Saturday of April through May 31, or as otherwise provided in § 41:06:13:02, in all other units. Units BST-BH1 <u>is</u> and BST-BH2 are the Black Hills units. Unit AST-ST1 is the archery unit. All other units are prairie units. The number of one-tag male turkey licenses issued is unlimited for residents and nonresidents in both the Black Hills and archery spring turkey hunting seasons. No more than 5,807 <u>10,000</u> one-tag male turkey and 600 <u>2,500</u> two-tag male turkey licenses may be issued to residents for the prairie spring turkey hunting season.</u>

41:06:13:02. Open units -- Exceptions. The following is a description of the open spring turkey hunting units:

(1) Unit BST-BH1: excluding Custer State Park, Wind Cave National Park, Mount Rushmore National Memorial, and Jewel Cave National Monument, that portion of Lawrence County south of Interstate 90; that portion of Meade County west and south of Interstate 90; those portions of Pennington and Custer Counties west of State Highway 79; that portion of Fall River County north and west of a line beginning at the junction of the South Dakota-Wyoming border and U.S. Highway 18, then east along U.S. Highway 18 to its junction with the Cheyenne River, then east along the Cheyenne River to its junction with State Highway 79, then north along State Highway 79 to its junction with the Custer County line;

(2) Unit BST-BH2: the same boundaries as Unit BST-BH1; Unit BST-BH2 is closed;

(7) Unit PST-08A: Davison and Hanson Counties; Unit PST-08A is open beginning on the second Saturday of April through April 30;

(8) Unit PST-08B: Davison and Hanson Counties; Unit PST-08B is open beginning on May 1 through May 31;

(33) Unit PST-44A: Lincoln County; Unit PST-44A is open beginning on the second Saturday of April through April 30;

(34) Unit PST-44B: Lincoln County; Unit PST-44B is open beginning on May 1 through May 31;

(43) Unit PST-58B: that portion of Stanley County located at the Oahe Downstream Recreation Area to include the U.S. Army Corps of Engineers Land which is east and southeast of Powerhouse Road. This unit is bordered by the Missouri River to the east and the emergency spillway canal to the south. Unit PST-58B-is open beginning on <u>the second Saturday of April-5</u> through April 30, but only to licensed persons who use a wheelchair;

Excluding that portion of Fall River County within Unit PST-27A, Licensees in prairie units that utilize the Cheyenne or White Rivers as unit boundaries may hunt within one mile of either side of the river boundary, as well as in the remainder of the unit for which the license is issued.

41:06:13:04. Application requirements and restrictions. The following apply to all applications for license and licenses issued under this chapter:

(1) A resident may apply for no more than one prairie unit license, one Unit BST-BH1 license, one Unit BST-BH2, and one Unit AST-ST1 license during the first license application period. A resident may not apply for or receive more than one Unit BST-BH1 license, one Unit BST-BH2, or one Unit AST-ST1 license;

(5) Good Earth State Park is closed to spring turkey hunting except for five turkey licensees who possess a valid spring turkey archery license and an archery turkey access permit. Adams Homestead and Nature Preserve is closed to spring turkey hunting except for 30 licensees who possess a valid spring turkey archery license and an archery turkey access permit and 20 licensees who possess a valid mentored spring turkey archery license and access permit. The access permits may be issued by lottery drawing. Each access permit is valid from the second first Saturday of April through April 30.

41:03:01:16. Restrictions on use of firearms, air guns, crossbows, and bows in the state park system -- Exceptions. Uncased firearms, air guns, crossbows, and bows are prohibited in the state park system with the following exceptions:

(5) From October 1 through April 30, uncased firearms, air guns, crossbows, and bows are authorized for licensed hunters in the state park system during established hunting seasons with the following restrictions:

(d) A person who possesses a valid turkey license for Unit PST-48A, as described in chapter 41:06:13, is permitted to have an uncased shotgun using shotshells, a crossbow, a bow, or a muzzleloading shotgun within the boundary of Sica Hollow State Park from the <u>second</u> first Saturday of April through May 31; and



COMMISSION PROPOSAL

Proposed changes:

- 1. Remove restrictions on when ice fishing shelters can be left overnight on public waters.
- 2. Remove language referencing gear specifications for the noncommercial take of smelt.
- 3. Remove the 15" minimum length limit for largemouth and smallmouth bass on Burke Lake in Gregory County and put in place a 15" minimum length limit for largemouth and smallmouth bass on Lake Mitchell in Davison County.

Department recommended changes to proposal:

1. Remove ice fishing shelter removal dates for inland waters and change the ice fishing shelter removal date on South Dakota-Minnesota border waters, from the last day in February to March 5.

SUPPORTIVE INFORMATION

- 1. Currently, no ice fishing house, fishing shanty, or other structure or shelter may remain upon the ice of any of the public waters of this state later than the last day of February of each year, unless authorized by the secretary. After this date, an ice fishing shelter needs to be removed from the ice daily. Removing this deadline on inland waters would allow anglers to keep ice fishing shelters in place during years when suitable ice conditions still exist past the previous deadline. Additionally, it would provide flexibility for anglers when access conditions prohibit retrieval of ice fishing shelters before the deadline. On South Dakota/Minnesota border waters, changing the ice fishing shelter removal deadline to March 5 would align regulations between the two states.
- 2. The rules governing methods of taking smelt include that nets legal for taking smelt are the same as those for taking bait for noncommercial purposes in 41:09:04:04. Restrictions on mesh-size and net size for minnow traps, seines, dip nets, lift nets, or cast nets used to take bait for noncommercial purposes were removed for 2022. Therefore, no restrictions on mesh size or net size for nets for taking smelt currently exist and the reference to restrictions needs to be removed from the rule.
- 3. Fish population surveys on Burke Lake in Gregory County indicate that the 15" minimum length limit was having no biological impacts on the fishery. Removing the regulation would provide additional opportunity for anglers to harvest bass. Fish population surveys on Mitchell Lake in Davison County indicated that a 15" minimum length limit would positively benefit the fishery. The regulation will protect smaller largemouth and smallmouth bass from harvest resulting in increased abundance and improved sizes of bass in a lake where recruitment of young fish to the fishery is severely limited.

DRAFT ADMINISTRATIVE RULE CHANGES

The following are proposed draft changes that are intended to incorporate the recommended changes adopted by the Commission.

- 41:07:01:16. Ice fishing shelter removal deadlines. On South Dakota-Minnesota border waters, Nno ice fishing house, fishing shanty, or other structure or shelter may remain upon the ice of any of the public waters of this state later than the last day of February March 5 of each year, unless authorized by the secretary. After this date, a shelter may be placed upon the ice of any of the public waters of this state at any time if the shelter is removed from the ice daily remain on the ice between midnight and one hour before sunrise only when occupied or attended.
- 2) 41:07:01:17. Liberalized take of silver carp, bighead carp, smelt, and lake herring. Smelt and lake herring may be taken by hook and line, seines, lift nets, cast nets, and dip nets. A net legal for taking smelt is a net as defined by § 41:09:04:04. Silver carp and bighead carp that inadvertently jump into any boat or are netted from the air using a dip net may be retained. No person may transport live smelt, live silver carp, or live bighead carp away from the water in which they were taken.
- 41:07:03:03. Daily, possession, and length limit restrictions on special management waters -- Additional restrictions described. Daily limit, possession limit, length limit, and additional restrictions on special management waters are as follows:

(1) Catfish may be taken without limit on the Grand, Moreau, Cheyenne, Belle Fourche, Bad, White, and Little Missouri Rivers; and in the inland waters of the Missouri River and its impoundments;

(2) In the waters of Lake Yankton in Yankton County and Burke Lake in Gregory County Lake Mitchell in Davison County, the minimum length limit for largemouth and smallmouth bass is 15 inches;

(3) In New Wall Dam in Pennington County, only those largemouth and smallmouth bass less than 14 inches in length or 18 inches or greater in length may be taken, and of the largemouth and smallmouth bass taken daily no more than one may be 18 inches or greater in length;

(4) In the Black Hills Fish Management Area:

(a) The areas described in subsections (b), (c), and (d) are restricted to artificial lures only and the use or possession of worms, baitfish, salmon eggs, corn, marshmallows, insects, moldable scented bait or naturally-occurring or man-made food intended to be used as bait, within 100 feet of the water in those areas, is prohibited;

(b) Rapid Creek, including the Pactola Stilling Basin below Pactola Dam to the foot bridge at Placerville Camp and Upper and Lower Yates Ponds at Cheyenne Crossing, are restricted to catch and release;

(c) Rapid Creek in Rapid City from Jackson Boulevard upstream to Park Drive is restricted to catch and release;

(d) Spearfish Creek from Homestake Hydro Dam No. 2 to Maurice Dam is restricted to catch and release for rainbow trout. Other trout species may be retained within established limits; and

(e) Only one trout 14 inches or greater in length, regardless of species, may be taken daily from streams within the Black Hills Fish Management Area. However, in the Black Hills Fish Management Area the minimum length limit for lake trout or brook trout-lake trout (splake) cross is 24 inches or greater in length and the daily limit is one;

(5) All waters statewide are restricted to catch and release only for muskellunge and northern-muskellunge (tiger) cross;

(6) The season on paddlefish is closed, except as provided in §§ 41:07:05:02 and 41:07:06:03.01;

(7) In inland waters only one walleye 20 inches or greater in length may be taken daily, except as provided in subdivisions (10) and (11) of this section;

(8) In Lakes Francis Case and Sharpe, the minimum length limit for walleye is 15 inches, from September 1 through June 30;

(9) In Angostura Reservoir, Shadehill Reservoir, and from the Ft. Randall Dam downstream to the South Dakota-Nebraska state line on the Missouri River, the minimum length limit for walleye is 15 inches;

(10) In Belle Fourche Reservoir and all waters contiguous thereto, including the terminal drop inlet canal, only those walleye less than 15 inches in length or 18 inches or greater in length may be taken, and of the walleye taken daily no more than one may be 18 inches or greater in length;

(11) In Twin Lakes in Minnehaha County and Horseshoe Lake in Day County, the daily limit for walleye of any species is one, 28 inches or greater in length;

(12) In Lynn and Middle Lynn Lakes in Day County, Opitz Lake in Day and Marshall Counties, Newell Lake in Butte County, and Curlew Lake in Meade County, the daily limit for walleye of any species combined is two and the minimum length limit is 15 inches;

(13) From the Ft. Randall Dam downstream to the South Dakota-Nebraska state line on the Missouri River, the daily limit for white bass is 15, possession limit 30; and

(14) In Reetz Lake in Day County, the daily limit is: one walleye 28 inches or greater in length; one yellow perch 14 inches or greater in length; one black crappie 15 inches or greater in length; and one bluegill 10 inches or greater in length, from May 1 through September 30.

Modify language in the rule listing importation requirements of fish to better describe current definitions of pathogens or diseases of regulatory concern (41:09:08:03.03).

Department recommended changes to proposal:

SUPPORTIVE INFORMATION

Current language in the rule on importation requirements for fish or fish reproductive products (41:09:08:03.04) needs to be modified to match language used to describe fish diseases and pathogens of concern in 41:09:08:03.03.

DRAFT ADMINISTRATIVE RULE CHANGES

The following are proposed draft changes that are intended to incorporate the recommended changes adopted by the Commission.

41:09:08:03.04. Importation requirements for fish or fish reproductive products. Before the department may issue an importation permit for fish or any fish reproductive product, a current fish health certification or a fish health inspection report must be submitted to the department.

A fish health inspection may only be conducted by:

(1) A person who is currently certified by the American Fisheries Society as a fish pathologist or a fish health inspector;

(2) A person who is currently authorized by the department to conduct official fish health inspections and who has completed a fish health inspection training program approved by the department; or

(3) A licensed veterinarian who has completed a fish health inspection training program approved by the department. Any fish health sample collected during a fish health inspection must be screened for regulated pathogens at a laboratory approved by the department.

Each fish health inspection and laboratory screening must be conducted according to procedures in "Suggested Procedures for the Detection and Identification of Certain Finfish and Shellfish Pathogens," or according to procedures of the "World Animal Health Organization (OIE) Aquatic Code," 19th Edition, 2016.

The application for an importation permit must will be denied if an emergency or prohibited disease or causative pathogen is detected in wild-caught fish or at an aquaculture facility. a pathogen of regulatory concern is detected in fish or fish reproductive products that are requested to be imported.

If a notifiable disease or causative pathogen is detected in wild-caught fish or at an aquaculture facility, tThe department's fish health official Aquatic Section Chief may allow the fish or fish reproductive products to be imported if the official determines the requested importation will not cause the introduction or spread of any notifiable aquatic animal pathogens pathogens of regulatory concern to areas in which they currently do not occur.

The fish or fish reproductive products to be imported, if obtained from man-made or natural waters and brought into a facility prior to shipping, must have been quarantined from other fish or fish reproductive products and inspected independently.

The fish or fish reproductive products to be imported, if obtained from man-made or natural waters, must have been inspected within the past twelve months. Other fish populations from this water must have been inspected within the same time period as determined by the department's fish health official.

The fish or fish reproductive products to be imported, if cultured at a<u>n aquaculture</u> facility, must have been inspected within the past twelve months.

SUPPORTIVE INFORMATION

- 1. Modifying the check time for hoop nets, traps, and setlines would reduce bycatch and mortality of non-targeted species, such as turtles. Staff believe most users are already following this timeline.
- 2. By allowing someone else to help tend hoop, trap, setlines and floatlines, as long the licensee is present, it would increase opportunity when using these gears and clarifies rule language for enforcement purposes. Allowing someone to assist a licensee with tending their equipment is beneficial for licensees with mobility issues.

DRAFT ADMINISTRATIVE RULE CHANGES

The following are proposed draft changes that are intended to incorporate the recommended changes adopted by the Commission.

- 41:07:08:05.02. Tending hoop nets, traps, setlines, and floatlines. All hoop nets, traps, and setlines must be checked and emptied of fish prior to 12 o'clock midnight of the second full calendar dayat least once in every 72-hour period, while being fished. All floatlines used for fishing must be under the direct supervision of and within the unaided observation of the licensee at all times.
- 41:07:08:05. Use of another person's <u>hoop nets, traps, setlines, or floatlines</u>. A person may not use or tend the hoop nets, traps, or setlines, <u>or floatlines</u> of another person <u>without</u> the licensee present.

Proposed changes:

- 1. Remove language regarding ZZ1 units (preference point only) for archery and snagging paddlefish seasons as these units are no longer available.
- 2. Add crossbows as a legal method of take for paddlefish during archery seasons.
- 3. Provide a permit to allow for assistance to be given to a disabled angler while participating in lawful fishing activities.

Department recommend changes to proposal:

None

SUPPORTIVE INFORMATION

- The ZZ-1 units (preference point only) are no longer available for users to submit applications. Users will still be able to obtain preference points if unsuccessful in the draw and during the open period to purchase preference points (September 15 – December 15) each year.
- 2. Allowing crossbows as a legal method of take for paddlefish would allow for increased opportunities for users and standardization within the state. Allowing crossbows and modifying boundaries would also align with Nebraska border waters.
- Creating a disabled angler assistance permit would allow for users who have mental or developmental disabilities to receive assistance from an unlicensed individual to perform lawful fishing activities. This would allow permitted individuals to receive assistance in snagging and landing paddlefish, for example.

DRAFT ADMINISTRATIVE RULE CHANGES

The following are proposed draft changes that are intended to incorporate the recommended changes adopted by the Commission.

41:07:05:02. Paddlefish season in special management areas. Any paddlefish angler 18 years of age and older shall obtain and have in possession a valid South Dakota fishing license and a valid, nontransferable paddlefish permit and associated unlocked tag to take or attempt to take a paddlefish with a bow and arrow <u>or crossbow</u> or take or attempt to take paddlefish or rough fish by snagging. A Nebraska resident possessing a South Dakota nonresident paddlefish permit is exempt from the South Dakota fishing license requirement if the Nebraska resident angler possesses a valid Nebraska fishing license or is legally exempt from compliance with Nebraska license or permit requirements. Any paddlefish angler under 18 years of age shall have a valid paddlefish permit and associated unlocked tag in possession while shooting paddlefish with bow and arrow <u>or crossbow</u> or snagging paddlefish or rough fish.

Each paddlefish caught and kept must have the tag immediately affixed to the fish and locked in the manner and place indicated in the instructions provided with the tag. Each paddlefish caught and

not kept must be immediately returned, unharmed, to the water from which it was taken. All paddlefish anglers shall cast for and hook their own fish.

No person may attempt to snag any fish after all paddlefish tags issued to the person have been locked.

(1) The snagging season for paddlefish and rough fish is open on the South Dakota-Nebraska boundary waters below Gavin's Point Dam and on the Big Sioux River from the I-29 bridge to the confluence of the Big Sioux River and the Missouri River from October 1 through October 31.

The snagging hours on the South Dakota-Nebraska Boundary waters and areas of the Big Sioux River open to paddlefish snagging are from 7:00 a.m. to 7:00 p.m. central time daily. Only a legal angler with a valid paddlefish permit and associated unlocked tag may snag paddlefish and rough fish during this season.

For the South Dakota-Nebraska boundary waters the annual quota of 3,200 fish is allocated by a permit and tag issued by each state according to the following schedule: Nebraska - 1,600 permits; South Dakota - 1,550 resident and 50 nonresident permits. Permits and associated tags are available by lottery drawing after application. Any resident or nonresident permit remaining after the first lottery drawing is available on a first-come, first-served basis to any person not already holding a paddlefish permit, who applies. After September 1, a person may apply for a second permit. A person may obtain a maximum of two permits a year. In addition to the 1,600 permits available in South Dakota, a person may apply for Unit SPF-ZZ1 for a preference point only and no opportunity for issuance of a permit.

(2) Paddlefish may be taken from sunrise to sunset from June 1 through June 30 from the Missouri River below Gavin's Point Dam with a bow and arrow, <u>or a crossbow downstream from the Highway 81 bridge</u>.

Except as provided in this rule, an archery paddlefish angler 18 years of age and older shall obtain and have possession of a valid South Dakota fishing license and a valid, nontransferable paddlefish permit and associated tag available from the licensing section of the department before participating in archery fishing for paddlefish. A Nebraska resident possessing a South Dakota nonresident archery paddlefish permit is exempt from the South Dakota fishing license requirement if the Nebraska resident angler possesses a valid Nebraska fishing license or is legally exempt from compliance with Nebraska license or permit requirements. Any paddlefish angler under 18 years of age shall have a valid paddlefish permit and associated tag in possession while archery fishing paddlefish.

Two hundred fifty-five archery permits and associated tags are available to residents by lottery drawing after application. Individual paddlefish archery anglers may apply for a second permit and associated tag if any are available following the initial lottery drawing. Anglers may obtain a maximum of two archery paddlefish permits and associated tags each year. An additional eight percent of the permits available to residents may be issued to nonresidents by lottery drawing after application. In addition to the 255 permits available in this state, a person may apply for Unit APF-ZZ1 for a preference point only and no opportunity for issuance of a permit.

(3) Paddlefish and rough fish season is open on the waters of Lake Francis Case and the White River up to the Highway 47 bridge from May 1 through May 31. Paddlefish may be taken by snagging or, bow and arrow <u>or crossbow</u>.

The snagging and archery hours on the waters of Lake Francis Case and the White River up to the Highway 47 bridge are from 6:00 a.m. through 9:00 p.m., central time daily. Only a legal angler with a valid paddlefish permit and associated unlocked tag may shoot paddlefish with a bow and arrow or snag paddlefish and rough fish during this season.

For the waters of Lake Francis Case and the White River up to the Highway 47 bridge, the annual quota of 350 fish is allocated by a permit and tag. Permits and associated tags are available by lottery drawing after application. Any resident permit remaining after the first lottery drawing is available first-come, first-served to any applicant not already holding a paddlefish permit. After April 1, a person may apply for a second permit. A person may obtain a maximum of two permits a year. In addition to the 350 permits available in this state, a person may apply for Unit SFC-ZZ1 for a preference point only and no opportunity for issuance of a permit.

41:09:12:08 Disabled angler assistance permit. The department may issue a disabled angler assistance permit to a person with a valid fishing license, or who is exempt from licensing requirements, who has a physical or developmental disability that prevents them from being able to

perform any of the activities associated with fishing. The permit allows another person to assist the permitted individual while fishing, in accordance with existing regulations, and without the need to possess a valid fishing license. A disabled angler assistance permit may be issued on either a temporary or permanent basis, dependent on the type of disability, at the discretion of the department.

COMMISSION PROPOSAL

<u>Proposed change</u>: Downlist the Peregrine Falcon (*Falco peregrinus*) from endangered to threatened on the list of state threatened and endangered bird species.

DEPARTMENT RECOMMENDATION

Recommended changes from proposal: None.

SUPPORTIVE INFORMATION

Peregrine Falcon populations rapidly declined between 1940 and 1970 (Hickey 1969) causing the species to be listed as federal endangered. Population declines were primarily attributed to the widespread use of the pesticide DDT, which accumulated in small birds eaten by peregrines and caused eggshell thinning and breakage. After successful reintroduction efforts the peregrine was federally delisted in 1999 (USFWS 1999, Cade et al. 2003) but remained on the state endangered species list in South Dakota due to its rarity in the state.

The GFP commission approved State Threatened and Endangered Species Status Review identified recovery criteria and goals to downlist and delist the peregrine from the state threatened and endangered species list. Criteria for downlisting the species from endangered to threatened stated that the peregrine population should consist of an average of two active nests for at least 5 years in a 6-year timespan, and the average productivity of the active nests must be 1.25 naturally produced young/pair across the 5-year period. A nest is considered active or occupied if there are observations of a mated pair on or near the nest or evidence of reproduction such as eggs, young or an incubating bird present.

The peregrine is considered a rare summer resident of the Black Hills and an uncommon statewide migrant. Historically there was a limited nesting distribution in western South Dakota with only two confirmed nesting records at separate locations in 1925 and 1948-1960 (Patton 1926, Pettingill and Whitney 1965). Since then, there were no documented nesting records until 2017, when surveys for peregrines in the spring and summer documented two confirmed and one potential nest locations in the northern and central Black Hills (Oakleaf 2017). Survey efforts have continued every year since 2017 resulting in the documentation of 5 nest locations. Three of these nests were documented as active during all 5 years of the surveys. The number of young fledged from 2017-2021 was calculated at 1.7 young per active pair (Oakleaf 2021, Table 1). These results indicate that the peregrine has met the criteria to downlist the species from endangered to threatened.




