May 4-5, 2023 Events Barn | Custer State Park

CALL MEETING TO ORDER AT 1:00 PM MT

Chair Rissler called the meeting to order at 1:00 pm MT at the Event Barn located in Custer State Park on May 4, 2023. Commissioners Stephanie Rissler, Julie Bartling, Jim White, Robert Whitmyre, Travis Bies, Jon Locken, and Charles Spring were present. The public and staff can listen via SDPD Livestream, and participate via conference, or in person, with approximately 73 total participants attending via Zoom or in person.

DIVISION OF ADMINISTRATION

1. CONFLICT OF INTEREST DISCLOSURE

Chair Rissler called for a conflict of interest to be disclosed. *None were present*.

2. APPROVE MINUTES OF THE PREVIOUS MEETING MINUTES

Chair Rissler called for any additions or corrections to the regular minutes of April 2023 meeting. Minutes are available at <u>https://gfp.sd.gov/commission/archives/</u>.

Motioned Bies, seconded by Bartling to APPROVE THE APRIL 2023 REGULAR COMMISSION MEETING MINUTES. The motion carried unanimously.

3. Additional Commissioner Salary Days

Chair Rissler called for any additional salary day from the commissioners. *None were present*.

4. LICENSE HOLDER LIST REQUEST

Administrative Director, Chris Petersen, presented the Commission with a License Holder List Request from Second Century Habitat Fund of Sioux Falls, SD.

5. SOUTH DAKOTA GO OUTDOORS UPDATE

Keith Fisk, Licensing Program Administrator, gave a brief update on GoOutdoors South Dakota system. He highlighted a few of the upcoming draws and application periods.

6. SECOND CENTURY HABITAT FUND GALA

Brian Bashore, Executive Director of SCHF (South Century Habitat Fund), extended a warm invitation to the public to join the upcoming SCHF Gala, scheduled for June 3rd in Sioux Falls, SD. The purpose of the event is to raise funds for ongoing habitat improvement projects, conducted in collaboration with the department. By attending the gala, participants will actively contribute to the preservation and enhancement of natural habitats in South Dakota

7. New Staff Introduction

Kevin Robling, Department Secretary, announced that Bruce Cull of Yankton, SD was appointed by Governor Noem on April 28, 2023, to take the final vacant seat on the Commission. His term will expire on January 24, 2024, as he will be finishing Russell Olson's term.

Black Hills Fly Fishers and National Wild Turkey Federation awarded the South Dakota Game, Fish and Parks department a \$40,000 check. As a result of a partnership effort between GFP, USFS Black Hills National Forest, Black Hills Fly Fishers, and the National Wild Turkey Federation, approximately 1.5 miles of Castle Creek below Deerfield Reservoir will be improved through a fencing project. The protection of this riparian area will benefit both the stream and trout population that thrives within it.

8. PETITION #188: BLOWGUN FISHING IN SOUTH DAKOTA

Motioned by Bies, seconded by Bartling to ADOPT RESOLUTION 23-14 TO DENY THE PETITION LEAGALIZE BLOWGUN FISHING IN SOUTH DAKOTA. The motion carried unanimously.

9. PETITION #189: BEAVER HUNTING & TRAPPING

Nancy Hilding of Black Hawk, South Dakota, representing the Prairie Hills Audubon Society submitted Petition #189 requesting the removal of beaver trapping and hunting from January 1, 2024, to January 1, 2027, on Black Hills National Forest lands.

Department Position: The department recommended denying the petition.

Motioned by Bartling, seconded by Spring to DENY THE PETITION TO REMOVE BEAVER TRAPPING AND HUNTING FROM JANUARY 1, 2024, TO JANUARY 1, 2027, ON BLACK HILLS NATIONAL FOREST LANDS. The motion carried unanimously.

Motioned by Whitmyre, seconded by Locken to ADOPT RESOLUTION 23-15 TO DENY PETITION TO REMOVE BEAVER TRAPPING AND HUNTING FROM JANUARY 1, 2024, TO JANUARY 1, 2027, ON BLACK HILLS NATIONAL FOREST LANDS. The motion carried unanimously.

10. PETITION #190: BEAVER HUNTING & TRAPPING

Nancy Hilding of Black Hawk, South Dakota, representing the Prairie Hills Audubon Society submitted Petition #190 requesting the removal of beaver trapping and hunting from January 1, 2024, to January 1, 2027, on Black Hills National Forest lands, and provide a method to impose a moratorium on other lands owned by the public.

Department Position: The department recommended denying the petition.

Motioned by Bartling, seconded by Spring to DENY THE PETITION TO REMOVE BEAVER TRAPPING AND HUNTING FROM JANUARY 1, 2024, TO JANUARY 1, 2027, ON BLACK HILLS NATIONAL FOREST LANDS WITH THE ABILITY TO IMPOSE A MORATORIUM. The motion carried unanimously.

Motioned by Whitmyre, seconded by Locken to ADOPT RESOLUTION 23-16 TO DENY PETITION TO REMOVE BEAVER TRAPPING AND HUNTING FROM JANUARY 1, 2024, TO JANUARY 1, 2027, ON BLACK HILLS NATIONAL FOREST LANDS WITH THE ABILITY TO IMPOSE A MORATORIUM. The motion carried unanimously.

PROPOSALS

11. FURBEARER SEASONS

Keith Fisk, Licensing Program Administrator, presented the commission with the Furbearer Season proposals. The department had no recommended changes to the following seasons:

- Beaver Trapping and Hunting Season (Chapter 41:08:01),
- Skunk, Opossum, Jackrabbit, Fox, Raccoon, and Badger Season (Chapter 41:08:01),
- Mink, Weasel, and Muskrat Hunting and Trapping Season (Chapter 41:08:01),
- Muskrat Hunting Season (Chapter 41:08:01).

Since the department had no recommended changes, THE COMMISSION TOOK NO ACTION ON THE PROPOSALS.

FINALIZATIONS

12. WATERFOWL HUNTING SEASON

WATERFOWL HUNTING SEASONS - CHAPTER 41:06:16

Department recommendations: No changes were recommended from the proposal.

Motioned by Bies, seconded by Locken to APPROVE THE FINALIZATION. The motion carried unanimously.

13. DEER HUNTING SEASONS

WEST RIVER PRAIRIE DEER HUNTING SEASONS – CHAPTER 41:06:20

Department recommendations: No changes were recommended from the proposal.

Motioned by Bies, seconded by Bartling to APPROVE THE FINALIZATION. The motion carried unanimously.

APPRENTICE HUNTER DEER SEASONS – CHAPTER 41:06:44

Department recommendations: No changes were recommended from the proposal.

Motioned by Bartling, seconded by Spring to APPROVE THE FINALIZATION. The motion carried unanimously.

YOUTH DEER HUNTING SEASON – CHAPTER 41:06:63

Department recommendations: No changes were recommended from the proposal.

Motioned by Whitmyre, seconded by Locken to APPROVE THE FINALIZATION. The motion carried unanimously.

CUSTER STATE PARK DEER HUNTING SEASON – CHAPTER 41:06:41

Department recommendations: Include an additional sentence in 41:06:41:01 to specify any deer and any whitetail licenses are valid through November 1 through November 30 and antlerless whitetail licenses valid from December 1 through December 15.

Motioned by White, seconded by Locken to APPROVE THE AMENDMENT TO THE PROPOSAL. The motion carried unanimously.

Motioned by Locken, seconded by Bartling to APPROVE THE FINALIZATION AS AMENDED. The motion carried unanimously.

NATIONAL WILDLIFE REFUGE DEER HUNTING SEASON – CHAPTER 41:06:36 Department recommendations: No changes were recommended from the proposal.

Motioned by Whitmyre, seconded by Bartling to APPROVE THE FINALIZATION. The motion carried unanimously.

14. DEER HUNTING SEASONS LICENSE ALLOCATIONS

Andrew Norton, Wildlife Program Administrator, presented the Commission with the proposed Deer Hunting Season License Allocations.

Motioned by Bartling, seconded by Locken to APPROVE DEER HUNTING SEASONS LICENSE ALLOCATIONS FINALIZATION. The motion carried unanimously.

DIVISION OF PARKS & RECREATION

15. LAKE OAHE UPDATE

During the presentation, Pat Buscher, Regional Supervisor, provided an update on the Lake Oahe Reservoir and its associated amenities. The Corps of Engineers' May forecast predicts a gradual increase in water levels throughout May and June, reaching an expected peak elevation of 1603.4. This bodes well for optimal water levels during the 4th of July and Labor Day weekends. Furthermore, out of the 21 department managed areas, boat ramps on Lake Oahe will be operational on 19 of them this summer. Additionally, the Spring Creek marina will be fully operational, with all 65 slips rented out for the season.

16. FORT SISSETON SMITHSONIAN EXHIBIT & FESTIVAL UPDATE

Alicia Tonsfeldt, Park Manager, informed the Commissioners about two upcoming events at Fort Sisseton. The much-anticipated Smithsonian exhibit, "Crossroads – Change in Rural America," will be on display from May 6 to June 25, 2023. Additionally, the Fort Sisseton Historical Festival is scheduled for June 2-4.

17. CUSTER STATE PARK: SYLVAN LAKE LODGE AND STORE CONSTRUCTION UPDATE

The Commission received a comprehensive update from Matt Snyder, Regional Supervisor, on the ongoing Sylvan Lake building projects. The presentation covered various aspects, including the progress of the repairs on Sylvan Lake Lodge following the 2021 fire incident. Additionally, updates were provided on the construction of the new Sylvan Lake Store and wedding venue, which are scheduled to be open to the public in May 2023.

18. CUSTER STATE PARK: RESOURCE MANAGEMENT

Brandon Prehn, Service Forester, shared a concise update on CSP's winter activities. This included completing approximately 320 acres of pre-commercial thinning in uneven-aged stands, along with 130 acres of pre-commercial thinning in even-aged stands. Meadow restoration mastication work covering 40/68 acres is currently under contract. A successful 100-acre prescribed fire was conducted in April 2023. Additionally, CSP created 10 acres of fuel breaks through pre-commercial thinning and slash piling, and initiated a 20-acre pre-commercial thinning project near the Badger Clark Historic Trail to enhance the area's health and productivity.

Bailey Eitel, Range Ecologist, also updated the commissioners that Custer State Park is collaborating with SDSU on an intriguing research project. The study involves tracking bison grazing patterns using GPS collars, enabling them to discern the specific areas of the park the bison utilize, particularly within the legion lake scar. Furthermore, the research aims to analyze the family structures within the bison herd. This research initiative holds promise for enhancing our understanding of bison behavior and their ecological impact within the park.

19. SPRING OPERATIONS IN PARKS, UPCOMING EVENTS, AND PARK RESERVATIONS

Jeff VanMeeteren, Parks & Recreation Director, delivered a comprehensive summary to the Commission, highlighting the extensive operational efforts undertaken by the park staff during the spring season to ensure the functionality of GF&P parks for recreational users. In addition to providing an overview of upcoming park events scheduled within the next 45 days, an update was given on the status of park reservations. It was noted that April witnessed a promising increase in park visitation by 7% and a corresponding revenue growth of 5% for the month. This positive trend reflects the successful management and appeal of the parks to the public.

DIVISION OF WILDLIFE

20. GROUSE MANAGEMENT PLAN

Alex Solem, Senior Upland Game Biologist, addressed the Commission, sharing valuable insights regarding the public comment period for the Prairie Grouse Action Plan.

Whitmyre moved to APPROVE THE AMENDMENT TO THE PRAIRIE GROUSE MANAGEMENT PLAN, 2023-2027, with Bartling seconding the motion. The motion carried unanimously.

Bies moved to ADOPT THE PRAIRIE GROUSE ACTION PLAN, 2023-2027 WITH THE AMENDMENT, with White seconding the motion. The motion carried unanimously.

21. LAND ACQUISITIONS

Ryan Wendinger, Habitat Program Administrator, provided a comprehensive update on recent land acquisitions during the meeting. He shared details about the Davis property located in Day County, specifically on Bitter Lake. The property spans 320 acres and has been appraised at a value of \$24,000. The agreed purchase price was also confirmed at \$24,000. Currently, a 30-day public comment period is open, and the commission will make a decision regarding the property at the June meeting.

Additionally, Ryan Wendinger informed the attendees about a land purchase made by Pheasants Forever in Stanley County. Pheasants Forever acquired 560 acres, which will be generously donated to GFP as part of their Build a Wildlife Area program. The acquisition of this property was made possible through financial donations from various groups and individuals who contributed to the fundraising effort. Similar to the Davis property, the commission will take action on this land during the June meeting after a 30-day public comment period.

22. Use of Prescribed Burns on Public Lands

During his presentation to the Commission, Ryan Wendinger, Habitat Program Administrator, discussed the topic of prescribed fire on public lands. He outlined the five main objectives of using prescribed fire in land management, emphasizing the importance of interagency collaboration and partnership with SD Wildland Fire. Wendinger provided an overview of the previous acres burned on public land and shared plans for acreage to be burned in 2023. He also provided details about the upcoming Little Bend fire.

23. RAPID CREEK HABITAT UPDATE

Grant Truskowski, Aquatic Habitat and Access Biologist, delivered a comprehensive update on Phase 2 of the habitat enhancement project in the Pactola Basin of Rapid Creek during the commission meeting. He shared key insights regarding the project's current timeline, highlighting the progress made thus far. Truskowski provided detailed information about the in-stream features implemented as part of the enhancement efforts. Additionally, he discussed relevant research conducted in relation to the project and highlighted the valuable partnerships and funding sources involved.

24. RIPARIAN HABITAT UPDATE

Ryan Wendinger, Habitat Program Administrator, shared details about winter meetings held by the staff to discuss existing private lands habitat programs and explore avenues for their expansion to align with landowners' goals and objectives. Additionally, Wendinger highlighted the development of a pilot Riparian Habitat Program aimed at improving riparian areas. He emphasized the ongoing collaboration with non-governmental organizations (NGOs), landowners, and other stakeholders in these efforts. The presentation showcased the commitment to enhancing habitat programs and fostering partnerships to make positive changes to riparian areas.

25. FISH WINTER SURVIVAL UPDATE

Jake Davis, Fisheries Program Administrator, shared information on the extent of winterkill of fish in lakes across South Dakota. In all areas of the state, staff confirmed winterkill, but the number of waters varied. Four waterbodies in western South Dakota experienced severe winterkill compared to 21 in central South Dakota that varied slight to sever. In eastern South Dakota, 22 waterbodies experience some level of winterkill while only 4 had been observed in northeastern portion of the state. More could be observed though as ice was still receding from area waters. Many waters across the state experienced no winterkill and the ones that had severe kills were in the process of being restocked with either hatchery or wild product.

26. WALLEYE SPAWNING EFFORTS

Jake Davis, Fisheries Program Administrator, provided an update on the walleye spawning efforts that the GFP was putting forth this year. Due to the weather, spawning efforts were delayed; however, eggs were taken on April 21st in the southeast portion of the state. Operations were also occurring on the Grand River and northeastern portion of the state. At the time of the meeting, approximately 100 million eggs had been collected and staff was confident that the statewide goal for walleye eggs of 120 million would be reached.

27. AVIAN INFLUENZA UPDATE

Rocco Murano, Senior Waterfowl Biologist, delivered an update to the commission regarding the current outbreak of Highly Pathogenic Avian Influenza (HPAI). He highlighted that the outbreak, which commenced in the late winter of 2022, has had an impact on the poultry industry, resulting in the loss or euthanization of 59 million birds. What sets this outbreak apart from previous ones is the significant mortality observed in wild birds, with approximately 26,000 documented deaths and many more suspected cases. To address the situation, SDGFP is actively collaborating with partners to aid poultry producers, document bird mortalities, and conduct operational monitoring programs to assess potential population-level impacts. This update underscored the collaborative efforts aimed at mitigating the effects of HPAI on both the poultry industry and wild bird populations.

28. LICENSE SALES UPDATE

During the meeting, Wildlife Director, Tom Kirschenmann, delivered a comprehensive summary of license sales from December 15 to April 30. Notably, there has been an increase in license sales in the past month, which can be attributed to improved weather conditions. Specifically, resident sales for fishing have shown an upward trend, while nonresident sales have slightly lagged compared to the previous year during the same period. Director Kirschenmann expressed optimism regarding the improving weather conditions and the promising number of bird observations reported over the past 2-3 weeks.

ADJOURN

Motioned by Bies, seconded by Bartling to ADJOURN THE MEETING. The motion carried unanimously.



- 3. The pelt shall be removed from the carcass and the carcass shall be surrendered to the Department. After the pelt has been tagged, it shall be returned to the trapper. Upon request, the carcass may be returned to the trapper after the carcass has been inspected and biological data collected.
- 4. Any river otter harvested after the 24-hour period following the close of the season, will be considered incidental take and shall be surrendered to the Department.
- 5. A person may only possess, purchase or sell raw river otter pelts that are tagged through the eyeholes with the tag provided by the Department or if the river otter was harvested on tribal or trust land of an Indian reservation or another state and is properly



DEPARTMENT RECOMMENDATION

Recommended changes from last year: Modify administrative rule to restrict the number of applications a person may submit during the third draw for Prairie Spring Turkey, Fall Turkey and Prairie Antelope.

SUPPORTIVE INFORMATION

The popularity of turkey and antelope hunting in South Dakota has seen a steady increase in applications. During the first and second draws for turkey and antelope seasons, applicants may apply for one license and can obtain a maximum of one license per season through those draws. During the third draw for turkey and antelope seasons, all remaining licenses are then pooled for residents and nonresidents, alike. Applicants that do not already possess a license from the first or second draw may submit up to five applications and those applicants that already possess a license, may submit up to four applications. The third draw also provides nonresident applicants better opportunities to draw a license in many units and some applicants are utilizing preference points to obtain a turkey license. During the 2023 third draw for Prairie Spring Turkey, 297 hunters were successful in two or more of their applications, resulting in 556 total hunters with two or more licenses through 3 draws and 1,279 hunters still without a single license (see table below). In many cases, hunters possessed five turkey licenses while there were other applicants that were not able to obtain a license. This change will allow more applicants the opportunity to hunt each year, rather than a smaller number of hunters possessing multiple licenses. With this modification, 799 applications from the 2,360 total applications would have been excluded in the third draw if all applicants were limited to one application. South Dakota has not conducted a third draw for prairie antelope within the past decade, but this modification would bring the structure of third draw for all three of these seasons into alignment.

The benefits of this rule modification include: 1) Creates more opportunity for more unique hunters; 2) Reduces draw and administrative rule complexity; 3) Reduces the amount of returned license when hunters apply for up to 5 licenses and then return successful licenses they do not want. Many times, there is not enough time to then reallocate licenses to other hunters; and 4) Creates consistency among turkey and antelope season draws.

DRAFT ADMINISTRATIVE RULE CHANGES

41:06:01:09. Application for unsold big game licenses -- Future eligibility. In antelope and turkey season units where resident and nonresident licenses are limited in number and licenses remain unsold following a second lottery drawing, a person who does not have a license in a season may

apply for <u>up to five one</u> leftover licenses in that season. and a person who already has a license in a season may apply for up to four additional licenses in that season. After the third drawing, a person may apply for an unlimited number of leftover licenses on a first-come first-serve basis. Nonresidents are not eligible for East River spring turkey or East River fall turkey licenses except for licenses unsold after the second lottery drawing. Purchase of an antelope or turkey license under this section does not affect the eligibility of the applicant in future lotteries.

A person who possesses two licenses for any of the Black Hills, East River, West River, Refuge, Custer State Park or Muzzleloader Deer Hunting Seasons may not apply for a license in the second combined lottery drawing for these seasons and a person who possesses one license may apply for one additional license for a season if the person does not possess a license for that season. A resident may submit one application for each season in the third lottery drawing if the resident does not possess a license for that season and in the fourth lottery drawing, a resident may submit no more than five applications. In the third and fourth leftover drawings, a nonresident who does not possess a license may submit one applications and a nonresident who possesses one license may submit one application for a season if the nonresident does not possess a license for that season. After the fourth lottery drawing, a person may obtain an unlimited number of licenses from a pool of remaining resident and nonresident licenses.

If licenses remain unsold after the initial lottery drawing for Black Hills Elk Hunting Season, Prairie Elk Hunting Season, and Archery Elk Hunting Season, a person who does not already have an elk license may apply for a license in a second or subsequent lottery drawing if the person submits the nonrefundable application fee and the applicable license fee with the application. Purchase and receipt of a first-choice elk license during the first lottery drawing counts as a successful application and affects eligibility in future first lottery drawings for the same season. Purchase and receipt of an elk license in the second drawing by the use of preference points is a successful application and affects eligibility in future lottery drawings for these seasons. Purchase and receipt of an elk license in the second lottery drawing without the use of preference points, or purchase and receipt of an elk license in subsequent drawings, does not affect eligibility or preference in future lottery drawings for these seasons.





Davis Property (Day County)

Location: Approximately five miles southwest of Waubay in Day County.

Size: 320 acres (298 acres water, 22 acres island).

Management Objective: Game Production Area – Offers waterfowl hunting off island and fishing opportunity (non-meandered waters of Bitter and Goose Lake). Connects 3,400 acres of GPA to a 120-acre parcel of GPA.

Easements: Wetland Reserve Program (WRP) easement that expires in 2042.

Previous Use: Enrolled in WIA since 2004.


Appraised Value: \$240,000 (\$750/acre)

Acquisition Cost: \$24,000 (\$75/acre)

WHEREAS, the Game, Fish and Parks Commission has reviewed any and all comments received relative to the intended purchase, and after consideration of the same, the Game, Fish and Parks Commission approves the purchase of said property for use as a Game Production Area;

NOW, THEREFORE, BE IT RESOLVED, the DEPARTMENT is authorized to complete negotiations for the purchase of the DAVIS PROPERTY and execute and consummate an agreement with William L. Davis, Duncan D. Davis, Jill L. Osborne, Nancy C. Hagen, Paul A. Davis, and Jeffrey B. Davis, which is acceptable to the DEPARTMENT to acquire by purchase at the price of \$24,000.00 the DAVIS PROPERTY for use as a Game Production Area.

Pheasants Forever Donation (Stanley County)

Location: Approximately thirty-five miles west and five miles north of Pierre in Stanley County.

Size: 560 Acres

Management Objective: Game Production Area – wildlife habitat management and public hunting access.

Easements: None

Previous Use: Enrolled in Conservation Reserve Program (CRP) and WIA for over 2 decades.

Appraised Value: Unknown – Pheasants Forever paid \$700,000 in December of 2022.

Acquisition Cost: Donation

Commission Acquisition Priorities: Parcels containing significant habitat and hunting opportunities for pheasants and parcels that have potential for high demand levels of outdoor recreation such as hunting, fishing, camping, trails, wildlife observation, water-based recreation.

Additional Information: The property will be named the "John Stengle Tract" of Frozen Man Creek Game Production Area due to a generous donation by the family to help Pheasants Forever purchase this property. NONRESIDENT FISHING REVENUE COMPARISON







This is not a good time to be making any increases in this number. With the on-going dry conditions, many wetlands have dried up, which may be OK today, but over a long hot summer we have no idea what those wetland conditions will look like in October. With fewer wetlands, there will be fewer places to hunt.

There has also been significant drain tile activity in the state and countless temporary wetlands, some of which would be full, productive wetlands in wetter years, are now gone forever. This trend continues and will be the case for years to come until South Dakota is similar to Minnesota when it comes to seasonal wetlands. There will be none.

This increase is being considered for commercial interests only. Resident hunters who are not tied to commercial interests continue to struggle with access to good hunting opportunities. We are not pushing for this and it is highly unlikely you will find one waterfowl hunter in the state without commercial or out of state ties that would support this.

We strongly oppose the proposed increase in nonresident waterfowl licenses.

As one of the premier duck breeding habitats, South Dakota should focus primarily on duck production, NOT revenue. When the focus is on revenue, the quality of hunting for South Dakotans becomes a slippery slope.

This is clearly illustrated by the commercialization of pheasant hunting. There is only a limited amount of public lands. Within the first few weeks of pheasant, the public lands' hunting is trashed as the birds have been spooked off. There are already plenty of locals who duck hunt, and there really are not that many ducks to hunt. Unlike pheasant hunting, ducks are not commercially farmed and stocked. Also unlike pheasant hunting, public lands are where duck hunters will mostly concentrate for the majority of their hunt. Duck identification skills and connection to the land may be questionable. Out of staters will be more likely than working South Dakotans to come in all week long and duck hunt instead of working, and there will be hardly any ducks left for the locals. This will also mess up lands for pheasant and deer later on.

Additionally, pheasant commercialization, combined with nonresidents walking public lands too, has priced regular people out of the pheasant hunting tradition (to the quality it used to and can be). We simply cannot afford paying to shoot birds. It would be a true shame if this happened to ducks as well.

When the duck population is doing well, that is something to be proud of: habitat management is adequate, and the amount of tags allocated is balanced. It is good to have a lot of ducks.

Don't wreck the one hunt regular working (i.e. not rich) South Dakotans can enjoy mostly by themselves. Let the people who live, work, are part of the community, pay taxes, and make things run here have their season. It is okay to have one season not swamped with nonresidents: they already have plenty of other hunting opportunities in South Dakota, which generates plenty of revenue. Leave the duck licensing the way it is, and look for revenue via other avenues.

South Dakota Fish And Game Turkey Season

Hello I am writing in regards to the last-minute changes of the South Dakota turkey season regulations. I would first like to add that I have actually spoken to others on how well in the past that your state had ran your wildlife management and regulations. So, when this years 2023 regulations were changed AFTER I had purchased my Archery Spring Turkey -- ST132 licence. I was surprised and disappointed.

When a bowhunter purchases a licence specifically for archery only and finds out only after arriving in South Dakota that there is no longer an archery season, it's wrong. Especially after purchasing the specific licence. We had travelled a great distance for the unique opportunity to hunt an archery only season for turkey.

Also, the closing of specific areas we had planned to hunt and had obtained permission for , created a difficult hunt, having to share public land with shotgun hunters. We actually had a minor disagreement with a shotgun hunter who was sitting right in the vicinity of our Blinds that were set up the day before. He was in essence ruining our hunt, knowing that we had blinds up. These are the kinds of problems that can occur when last minute changes are made unknowingly to the hunting public.

The other concern is without having the aid of local hunters, we would not have known of any of the changes and the area closures and would have been breaking the law.

I'm hoping in the future any changes are made in a timely manner, and made public to the licence holders to prevent issues we encountered.

Archery seasons are designed specifically to allow bowhunters to hunt closer and use unique techniques to have a chance at success before gun hunting is open. We were denied that opportunity in 2023.

Thanks for your time and I hope this letter is brought to the attention of those who made the changes.
